7 **For An Act To Be Entitled**

8 "AN ACT TO REPEAL CERTAIN TAXES AND FEES LEVIED BY
9 ARKANSAS CODE ANNOTATED WHICH GENERATE MINIMAL REVENUE AND
10 ARE AN ADMINISTRATIVE BURDEN ON THE STATE; AND FOR OTHER
11 PURPOSES."

13 **Subtitle**

14 "TO REPEAL THE TAXES AND FEES LEVIED WHICH GENERATE
15 MINIMAL REVENUE AND CREATE AN ADMINISTRATIVE BURDEN ON THE
16 STATE."

17

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

19

20 SECTION 1. Arkansas Code Annotated §26-56-205(b) (1) is amended to read
21 as follows:

22 "(b) (1) Concurrently with the filing of an application for a license,
23 every dealer shall file with the director a bond in such amount as may be
24 determined by the director, not to exceed five thousand dollars (\$5,000), to
25 assure the performance by the dealer of the requirements of this chapter."

27 SECTION 2. (a) Arkansas Code Annotated §23-3-510(b) is repealed;
28 (b) Subchapter 3 of Chapter 57 of Title 26 of Arkansas Code Annotated
29 is repealed;

30 (c) Subchapter 7 of Chapter 57 of Title 26 of Arkansas Code Annotated
31 is repealed;

32 (d) Arkansas Code Annotated §26-58-211 is repealed;
33 (e) Arkansas Code Annotated §26-76-203 is repealed.

35 SECTION 3. Arkansas Code Annotated §17-49-201(c) is repealed.

2 SECTION 4. Arkansas Code Annotated §17-49-201(d) is hereby amended to
3 read as follows:

4 "(d) (1) In order to continue to hold a valid registration in a
5 subsequent year each operator shall annually renew his registration.

6 (2) Each registration shall expire on December 31 of each year."

7

8 SECTION 5. Arkansas Code Annotated §17-49-203 is amended to read as
9 follows:

10 "A bona fide civic club in existence for at least one (1) year, or a
11 nonprofit organization, or a religious organization or church, or a local
12 government entity or school, or any organization auxiliary to or affiliated
13 with such local governmental entities or schools, including, but not limited
14 to, county fair boards and school booster clubs, shall be exempt from the
15 requirements of §17-49-201(c), and §17-49-202."

16

17 SECTION 6. All laws and parts of laws in conflict with this act are
18 hereby repealed.

19

20 SECTION 7. All provisions of this act of a general and permanent nature
21 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
22 Revision Commission shall incorporate the same in the Code.

23

24 SECTION 8. If any provision of this act or the application thereof to
25 any person or circumstance is held invalid, such invalidity shall not affect
26 other provisions or applications of the act which can be given effect without
27 the invalid provision or application, and to this end the provisions of this
28 act are declared to be severable.
