HOUSE BILL

For An Act To Be Entitled

8 "AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES AND
9 OPERATING EXPENSES OF THE ARKANSAS STATE HIGHWAY AND
10 TRANSPORTATION DEPARTMENT FOR THE BIENNIAL PERIOD ENDING
11 JUNE 30, 1995; AND FOR OTHER PURPOSES."

Subtitle

14 "AN ACT TO APPROPRIATE FUNDS TO THE ARKANSAS HIGHWAY AND
15 TRANSPORTATION DEPARTMENT FOR THE 1993-95 BIENNIUM."

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

19 SECTION 1. REGULAR SALARIES. There is hereby established for the
20 Arkansas State Highway & Transportation Department, for the biennial period
21 ending June 30, 1995, the following maximum number of regular employees and
22 the maximum annual salary for such employees; and no greater salary than that
23 established herein shall be paid to any employee from appropriations
24 hereinafter made for said Department. The annual salaries to be paid to each
25 employee authorized herein shall be determined by the Arkansas Highway
26 Commission within the limitations as set out in this Section and the funds and
27 the appropriations made available for such purposes. All positions established
28 herein shall be exempt from the provisions of the Uniform Personnel
29 Classification and Compensation Act (Arkansas Code §§21-5-201 et seq.), or its
30 successor, but shall not be exempt from the provisions of the Regular Salaries
31 Procedures and Restrictions Act. Provided further that the salaries for the
32 pay periods beginning June 24, 1993, and June 23, 1994, can be paid from the
33 salaries and overtime authorized for the fiscal years ending June 30, 1994 and
34 June 30, 1995 respectively.

24 SECTION 8. OVERTIME. The Arkansas Highway Commission is hereby
25 authorized to pay overtime to its employees, and the administration thereof
26 shall be in accordance with the policies established by the Commission. The
27 executives and administrators of the Department shall be exempt from overtime
28 payments as will certain professional employees occupying positions
29 specifically exempt under the overtime policies established by the Commission.

30 For the purpose of paying overtime, any portion of Item 2 of Section 2
31 may be transferred to and be combined with Item 1 (Salaries) in Section 2 at
32 the discretion of the Highway Commission and notice to the Auditor of State
33 and the Director of Finance and Administration. Thereafter, overtime
34 applicable to salaries may be paid from Item 1 of Section 2. One state
35 warrant may be issued to each employee for the total of the regular salaries

1 and overtime earned. The amount of the line items in Section 1 authorized for
2 salaries, may be exceeded for employees eligible for overtime to the extent of
3 the overtime paid to said employees. Overtime thus paid shall be identifiable
4 for each employee, and in total for all employees, on the voucher or other
5 record that is submitted to support the issuance of payroll warrants.

6

7 SECTION 9. TRANSFERS AUTHORIZED. Any savings in the amount
8 appropriated in Section 2 for Item (1) Salaries, Item (2) Overtime, Item (3)
9 Personal Services Matching, or any sub-item of Item (4) Maintenance,
10 Operation, Construction, etc., may be transferred by the Director of the State
11 Highway and Transportation Department to any sub-item of Item (4), by
12 notifying the Director of Finance and Administration and the Auditor of State
13 to transfer said savings to a specific sub-item of Item (4) and make it
14 available for said purpose during the then current fiscal year.

15

16 SECTION 10. SOCIAL SECURITY AND RETIREMENT. The State Highway and
17 Transportation Department's expenses for Social Security Matching and
18 administrative costs thereof are to paid to the Social Security Matching Fund,
19 in accordance with the regulations or instructions of the Department of
20 Finance and Administration. The State Highway and Transportation Department's
21 expenses for Highway Retirement Matching shall be paid to the State Highway
22 Employees Retirement System, in accordance with the instructions of said
23 system, as directed by the State Highway Commission.

25 SECTION 11. PERSONAL SERVICES MATCHING TRANSFER. Provided that in the
26 event amounts appropriated in Item (3) Section 2, Personal Services Matching,
27 are insufficient in either year of the biennium to pay the amounts at the
28 rates stipulated by law to be paid for each of these items, an additional
29 amount as determined and requested by the Director of Highways and
30 Transportation will be transferred by the Director of Finance and
31 Administration and the Auditor of State from Item (4) Maintenance, Operation,
32 Construction, Reconstruction, etc., to Item (3) in Section 2, to enable the
33 State Highway and Transportation Department to pay the required matching
34 funds.

35

1 SECTION 12. UNIFORM ALLOWANCE. The Arkansas Highway Commission is
2 hereby authorized to pay from funds appropriated for Maintenance and Operation
3 a uniform allowance of Twelve Hundred Dollars (\$1,200) per annum for all
4 uniformed personnel (Arkansas Highway Police Patrol Officer through Chief,
5 Police Division) of the Arkansas Highway Police Division. The above mentioned
6 allowance shall be equated to and paid at the rate of One Hundred Dollars
7 (\$100) per month for each month of the employment for those eligible personnel
8 of the Arkansas Highway Police Division. Provided further, that when
9 uniformed personnel are hired, they shall be paid an initial lump-sum uniform
10 allowance of Two Hundred Dollars (\$200) that shall be in addition to the
11 monthly allowance as herein provided.

12

13 SECTION 13. TOOL ALLOWANCE. The Arkansas Highway Commission is hereby
14 authorized to pay from funds appropriated for Maintenance and Operation a tool
15 allowance of Three Hundred Sixty Dollars (\$360) per annum for each Mechanic,
16 Electric, Plumbing, and Mechanical Repairer, Welder, or Body Repairer and
17 Painter employed by the State Highway and Transportation Department who work
18 on Highway equipment and facilities. The aforementioned allowance shall be
19 equated to Thirty Dollars (\$30.00) per month for each month of employment for
20 the eligible personnel of this department.

21

22 SECTION 14. LIABILITY INSURANCE PREMIUM REIMBURSEMENT. The Arkansas
23 Highway Commission is hereby authorized to reimburse from funds appropriated
24 in Item (4) of Section 2 of this Act, State Highway and Transportation
25 Department employees for personal liability insurance premiums paid by State
26 Highway and Transportation Department employees for liability coverage on
27 state owned vehicles of the Highway and Transportation Department up to a
28 maximum of Fifty Dollars (\$50) per annum per employee, at the option of the
29 eligible employee. The Arkansas Highway Department is hereby authorized to
30 pay for amounts not to exceed \$25,000 per claim for damages to personal
31 property of others resulting from the operation of any motor vehicle or other
32 motorized equipment of the Department upon determination by the State Claims
33 Commission that the claim is valid after hearing the facts thereof and after
34 prior review by the Legislative Claims Committee and Legislative Council.

35

1 SECTION 15. MOVING EXPENSE. The Arkansas Highway Commission is hereby
2 authorized to pay from funds appropriated from Maintenance and Operation the
3 actual expense of moving the household and personal property of those
4 employees of the Department who, because of their job assignment, are required
5 to move their place of residence by the Highway Commission, through the
6 Director, subject to the approval by the Director, for each move so required.

7

8 SECTION 16. Arkansas Code 27-65-137 is hereby amended to read as
9 follows:

10 "27-65-137. Special expense allowance.

11 Due to his exacting and special duties, the Director of the Highway and
12 Transportation Department is hereby authorized an expense allowance of
13 five hundred dollars (\$500) per month upon approval of the Highway
14 Commission. The Arkansas Highway Commission shall provide for an
15 expense allowance of up to two thousand dollars (\$2,000) per annum for
16 each chief, captain, first lieutenant, second lieutenant, sergeant,
17 corporal, patrolman first class, patrolman and motor carrier safety
18 inspector of the Arkansas Highway Police."

19

20 SECTION 17. UNEMPLOYMENT BENEFITS. The Arkansas State Highway and
21 Transportation Department is authorized to pay from Item (3) of Section 2
22 hereof, the Unemployment Benefits and Workers Compensation Benefits, at a rate
23 not in excess of the Agency's experience rate, under the provisions of
24 regulations established by the Department of Finance and Administration.

25

26 SECTION 18. TRANSFER PROVISION. Provided, that any unexpended
27 appropriation balance, remaining on June 30, 1994, in the appropriation
28 authorized in Section 2 hereof, for Item (1) Regular Salaries; Item (2)
29 Overtime Compensation; Item (3) Personal Services Matching; and Item (4)
30 Maintenance, Operations, Construction, and other items shall be transferred by
31 the Chief Fiscal Officer and the Auditor of State to Item (4) (A) Oper.
32 Expenses in Section 2 hereof, for the fiscal year beginning July 1, 1994 and
33 ending June 30, 1995, and made available for use in said year, and that any
34 unexpended appropriation balance made herein for Highway Special Construction,
35 Federal Highway Trust, State Aid Roads and Highway Safety Special remaining on

1 June 30, 1994 shall be transferred forward by the Chief Fiscal Officer and the
2 Auditor of State to the fiscal year beginning July 1, 1994, and ending June
3 30, 1995, and made available for the same purposes.

4

5 SECTION 19. REPORTING REQUIREMENTS. The Arkansas Highway Commission is
6 hereby authorized to take appropriate action as necessary to restrict or
7 reduce the operating, administration, and other associated costs of the State
8 Highway and Transportation Department, including the Arkansas Highway Police
9 Division, for the biennial period ending June 30, 1995. Provided further,
10 that the Arkansas Highway Commission is directed to furnish the Arkansas
11 Legislative Council with an expenditure status report regarding the financial
12 activities of the State Highway and Transportation Department at least
13 quarterly, beginning no later than September 30, 1989.

14

15 SECTION 20. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
16 authorized by this Act shall be limited to the appropriation for such agency
17 and funds made available by law for the support of such appropriations; and
18 the restrictions of the State Purchasing Law, the General Accounting and
19 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
20 Procedures and Restrictions Act, or their successors, and other fiscal control
21 laws of this State, where applicable, and regulations promulgated by the
22 Department of Finance and Administration, as authorized by law, shall be
23 strictly complied with in disbursement of said funds.

24

25 SECTION 21. LEGISLATIVE INTENT. It is the intent of the General
26 Assembly that any funds disbursed under the authority of the appropriations
27 contained in this Act shall be in compliance with the stated reasons for which
28 this Act was adopted, as evidenced by the Agency Requests, Executive
29 Recommendations and Legislative Recommendations contained in the budget
30 manuals prepared by the Department of Finance and Administration, letters, or
31 summarized oral testimony in the official minutes of the Arkansas Legislative
32 Council or Joint Budget Committee which relate to its passage and adoption.

33

34 SECTION 22. CODE. All provisions of this Act of a general and
35 permanent nature are amendatory to the Arkansas Code of 1987 Annotated and the

1 Arkansas Code Revision Commission shall incorporate the same in the Code.

2

3 SECTION 23. SEVERABILITY. If any provision of this Act or the
4 application thereof to any person or circumstance is held invalid, such
5 invalidity shall not affect other provisions or applications of the Act which
6 can be given effect without the invalid provision or application, and to this
7 end the provisions of this Act are declared to be severable.

8

9 SECTION 24. GENERAL REPEALER. All laws and parts of laws in conflict
10 with this Act are hereby repealed.

11

12 SECTION 25. EMERGENCY CLAUSE. It is hereby found and determined by the
13 Seventy-Ninth General Assembly, that the Constitution of the State of Arkansas
14 prohibits the appropriation of funds for more than a two (2) year period; that
15 the effectiveness of this Act on July 1, 1993 is essential to the operation of
16 the agency for which the appropriations in this Act are provided, and that in
17 the event of an extension of the Regular Session, the delay in the effective
18 date of this Act beyond July 1, 1993 could work irreparable harm upon the
19 proper administration and provision of essential governmental programs.
20 Therefore, an emergency is hereby declared to exist and this Act being
21 necessary for the immediate preservation of the public peace, health and
22 safety shall be in full force and effect from and after July 1, 1993.
