7 **For An Act To Be Entitled**

8 "AN ACT TO AMEND ARKANSAS CODE ANNOTATED 27-14-1015(e) TO
9 MAKE IT UNLAWFUL TO DISPLAY UNLAWFULLY OBTAINED ANNUAL
10 TABS OR DECALS ON PERMANENT LICENSE PLATES; AND FOR OTHER
11 PURPOSES."

13 **Subtitle**

14 "AN ACT TO MAKE IT UNLAWFUL TO DISPLAY UNLAWFULLY OBTAINED
15 ANNUAL TABS OR DECALS ON PERMANENT LICENSE PLATES."

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

18

19 SECTION 1. Arkansas Code Annotated § 27-14-1015(e) is amended to read
20 as follows:

21 "(e) (1) It shall be unlawful for any applicant for registration of a
22 motor vehicle to fraudulently obtain registration by producing to the director
23 proof of payment of personal property taxes showing that his personal property
24 taxes have been paid, or that he owes no taxes when in fact the applicant does
25 owe taxes in one (1) or more counties. Further, it shall be unlawful to
26 display on a permanent license plate an annual tab or decal which was obtained
27 fraudulently or unlawfully, or was obtained pursuant to the registration of a
28 permanent license plate other than the permanent license plate upon which it
29 is displayed.

30 (2) Any person violating the provisions of this subsection shall
31 be guilty of a misdemeanor and, upon conviction, shall be subject to a fine of
32 not less than twenty-five dollars (\$25.00) nor more than two hundred fifty
33 dollars (\$250), and the director shall cancel the registration of all vehicles
34 registered in the name of that person."

35

1 SECTION 2. All provisions of this act of a general and permanent nature
2 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
3 Revision Commission shall incorporate the same in the Code.

4

5 SECTION 3. If any provision of this act or the application thereof to
6 any person or circumstance is held invalid, such invalidity shall not affect
7 other provisions or applications of the act which can be given effect without
8 the invalid provision or application, and to this end the provisions of this
9 act are declared to be severable.

10

11 SECTION 4. All laws and parts of laws in conflict with this act are
12 hereby repealed.
