7 **For An Act To Be Entitled**

8 *"AN ACT TO AUTHORIZE A FEASIBILITY STUDY FOR A FORESTRY
9 MUSEUM; AND FOR OTHER PURPOSES."*

11 **Subtitle**

12 *"AN ACT TO AUTHORIZE A FEASIBILITY STUDY FOR A FORESTRY
13 MUSEUM."*

14

15 WHEREAS, museums preserve our heritage for the benefit, enjoyment, and
16 education of the citizens of all ages and from every community in Arkansas;
17 and

18 WHEREAS, museums are unique cultural resources through the preservation,
19 exhibition, and documentation of historically, scientifically, and
20 artistically significant facts and artifacts; and

21 WHEREAS, museums provide a unique educational tool which can directly
22 supplement the state's educational system through demonstrating the use and
23 significance of said artifacts; and

24 WHEREAS, the *forestry and timber industry* has provided a significant
25 number of jobs and income in the State of Arkansas;

26

27 NOW THEREFORE,

28 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

29

30 SECTION 1. (a) *The Arkansas Forestry Commission and the Arkansas
31 Department of Parks and Tourism and a member of the House appointed by the
32 Speaker of the House and a member of the Senate appointed by the President Pro
33 Tempore are jointly authorized to study the feasibility of establishing a
34 State Historical Museum to be known and operated as the "Arkansas Forestry
35 Museum".*

1 (b) The feasibility study shall be completed prior to July 1, 1994.

2 (c) The feasibility study shall determine the size of the facility
3 needed and construction cost estimates for said facility.

4 (d) The feasibility study shall determine the annual costs to maintain
5 and operate the museum.

6 (e) The feasibility study shall identify areas of responsibility for
7 the Forestry Commission and Parks and Tourism for funding, planning,
8 construction, staffing, operating and maintaining the museum.

9

10 SECTION 2. The feasibility study shall define the mission and scope of
11 the Arkansas Forestry Museum with respect to the acquisition, cataloging,
12 preservation, exhibition and interpretation of records, tools, equipment,
13 machinery, and materials used by foresters and the timber industry in
14 Arkansas.

15

16 SECTION 3. The feasibility study shall determine the methods and
17 criteria for selecting the site for the museum.

18

19 SECTION 4. The feasibility study shall determine the organization,
20 size, geographic representation, state agency representation, timber industry
21 representation, term limits, and authority for a "Forestry Museum Advisory
22 Committee".

23

24 SECTION 5. All provisions of this act of a general and permanent nature
25 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
26 Revision Commission shall incorporate the same in the Code.

27

28 SECTION 6. If any provision of this act or the application thereof to
29 any person or circumstance is held invalid, such invalidity shall not affect
30 other provisions or applications of the act which can be given effect without
31 the invalid provision or application, and to this end the provisions of this
32 act are declared to be severable.

33

34 SECTION 7. All laws and parts of laws in conflict with this act are
35 hereby repealed.
