## For An Act To Be Entitled

7 "AN ACT TO AMEND ARKANSAS CODE 13-9-101 (b) CONCERNING THE  
8 EX OFFICIO MEMBERS OF THE ARKANSAS ENTERTAINERS HALL OF  
9 FAME BOARD; AND FOR OTHER PURPOSES."

### Subtitle

11 "AN ACT CONCERNING THE EX OFFICIO MEMBERS OF THE ARKANSAS  
12 ENTERTAINERS HALL OF FAME BOARD."

13

14 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

15

16 SECTION 1. Arkansas Code 13-9-101 (b) is amended to read as follows:

17 " (b) (1) The board shall be composed of nine (9) members, who shall be  
18 appointed by the Governor for terms of six (6) years each.

19 (2) Two (2) board members shall be appointed from each  
20 congressional district in the state and one (1) shall be appointed at large.

21 (3) (A) Additionally, the President Pro Tempore of the Senate and  
22 the Speaker of the House shall be ex officio nonvoting members.

23 (B) In addition, the members of the board shall appoint two  
24 (2) ex officio nonvoting members.

25 (4) Members of the board shall not be compensated for their  
26 services, but each member shall be entitled to reimbursement for expenses  
incurred in attending board meetings."

27

28 SECTION 2. The uncodified portion of Section 2 of Act 467 of 1987,  
29 which required the Secretary of State to provide temporary office space and  
30 staff for the Arkansas Entertainers\_ Hall of Fame Board, is repealed.

31

32 SECTION 3. All provisions of this act of a general and permanent

1 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas  
2 Code Revision Commission shall incorporate the same in the Code.

3

4 SECTION 4. If any provision of this act or the application thereof to  
5 any person or circumstance is held invalid, such invalidity shall not affect  
6 other provisions or applications of the act which can be given effect without  
7 the invalid provision or application, and to this end the provisions of this  
8 act are declared to be severable.

9

10 SECTION 5. All laws and parts of laws in conflict with this act are  
11 hereby repealed.
