## 7 **For An Act To Be Entitled**

8 "AN ACT TO AMEND ARKANSAS CODE ANNOTATED § 6-18-208 TO  
9 CLARIFY THE REQUIRED DOCUMENTS THAT A PARENT OR GUARDIAN  
10 MUST PRESENT FOR A CHILD TO BE ADMITTED TO PUBLIC SCHOOL;  
11 AND FOR OTHER PURPOSES."

## 14 **Subtitle**

15 "TO AMEND THE ARKANSAS CODE TO CLARIFY WHAT DOCUMENTS ARE  
16 REQUIRED FOR A CHILD TO BE ADMITTED TO PUBLIC SCHOOL."

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20 SECTION 1. Arkansas code § 6-18-208 is hereby amended to read as  
21 follows:

22 "6-18-208. Birth certificate and social security number required for  
23 enrollment in public school - Exceptions.

24 (a) Prior to a child\_s admission to an Arkansas public school, a school  
25 district shall request the parent, guardian, or other responsible person to  
26 furnish the child\_s social security number and shall inform the parent,  
27 guardian, or other responsible person that, in the alternative, they may  
28 request that the school district assign the child a nine (9) digit number  
29 designated by the Department of Education.

30 (b) Prior to a child\_s admission to an Arkansas public school, the  
31 parent, guardian, or responsible person shall provide the school district with  
32 one (1) of the following documents indicating the child\_s age:

33 (1) A birth certificate;

34 (2) A statement by the local registrar or a county recorder  
35 certifying the child\_s date of birth;

- 1                             (3) An attested baptism certificate;  
2                             (4) A passport;  
3                             (5) An affidavit of the date and place of birth by the child\_s  
4 parent or guardian; or  
5                             (6) Previous school records."

7                 SECTION 2. All provisions of this act of a general and permanent  
8 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas  
9 Code Revision Commission shall incorporate the same in the Code.

10

11                 SECTION 3. If any provision of this act or the application thereof to  
12 any person or circumstance is held invalid, such invalidity shall not affect  
13 other provisions or applications of the act which can be given effect without  
14 the invalid provision or application, and to this end the provisions of this  
15 act are declared to be severable.

16

17                 SECTION 4. All laws and parts of laws in conflict with this act are  
18 hereby repealed.
