7 **For An Act To Be Entitled**

8 "AN ACT TO ESTABLISH THE SALARY OF SECRETARY-CASE
9 COORDINATORS OF THE EIGHTEENTH JUDICIAL CIRCUIT-EAST; AND
10 FOR OTHER PURPOSES."

12 **Subtitle**

13 "AN ACT TO ESTABLISH THE SALARY OF SECRETARY-CASE
14 COORDINATORS OF THE EIGHTEENTH JUDICIAL CIRCUIT-EAST."
15

16 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

17

18 SECTION 1. Each circuit judge, chancery judge, circuit/chancery judge,
19 and circuit/chancery judge-juvenile, Eighteenth Judicial Circuit-East, may
20 employ a secretary-case coordinator to serve each judge at the pleasure of the
21 appointing judge, at an annual salary based upon the classification in the
22 table in Section 2 payable in equal monthly installments by Garland County.

23

24 SECTION 2. No payment of salary may be made except in conformity with
25 the salary rates assigned in the table below and only after the appointing
26 judge has certified in writing the term of the employee_s experience to the
27 County Clerk:

29 I	Entry Level	\$19,500.00
30 II	18 Months	\$20,250.00
31 III	36 Months	\$21,000.00
32 IV	54 Months	\$21,630.00
33 V	72 Months	\$22,278.90
34 VI	90 Months	\$22,947.26
35 VII	108 Months	\$23,635.68

1 The appointing judge shall have discretion in certifying or omitting to
2 certify increases in salary above the entry level.

3

4 SECTION 3. It is hereby found and determined by the General Assembly
5 that the secretary-case coordinators of the several courts of the Eighteenth
6 Judicial Circuit-East have varying experience and beginning in 1993,
7 classifications in Section 2 should be implemented and is necessary to the
8 proper administration of justice.

9

10 SECTION 4. All provisions of this act of a general and permanent nature
11 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
12 Revision Commission shall incorporate the same in the Code.

13

14 SECTION 5. If any provision of this act or the application thereof to
15 any person or circumstance is held invalid, such invalidity shall not affect
16 other provisions or applications of the act which can be given effect without
17 the invalid provision or application, and to this end the provisions of this
18 act are declared to be severable.

19

20 SECTION 6. All laws and parts of laws in conflict with this act are
21 hereby repealed.
