7 **For An Act To Be Entitled**

8 "AN ACT TO MAKE AN APPROPRIATION TO THE DEPARTMENT OF
9 FINANCE AND ADMINISTRATION - DISBURSING OFFICER FOR
10 PERSONAL SERVICES AND OPERATING EXPENSES OF THE VARIOUS
11 TECHNICAL INSTITUTES AND COMPREHENSIVE LIFELONG LEARNING
12 CENTERS WHICH SHALL BE SUPPLEMENTAL AND IN ADDITION TO
13 THOSE FUNDS APPROPRIATED BY ACT 1246 OF 1991, FOR THE
14 REMAINDER OF THE BIENNIAL PERIOD ENDING JUNE 30, 1993; AND
15 FOR OTHER PURPOSES."

17 **Subtitle**

18 "AN ACT FOR THE DEPARTMENT OF FINANCE AND ADMINISTRATION -
19 DISBURSING OFFICER SUPPLEMENTAL APPROPRIATION."

21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23 SECTION 1. APPROPRIATIONS. There is hereby appropriated, to the
24 Department of Finance and Administration - Disbursing Officer, to be payable
25 from the Work Force 2000 Development Fund, for providing supplemental
26 assistance in meeting personal services and operating expense requirements of
27 the technical institutes and comprehensive lifelong learning centers as
28 authorized in Section 6(a) of Act 1246 of 1991 which shall be supplemental and
29 in addition to those funds appropriated in Section 1 of Act 1246 of 1991, for
30 the remainder of the biennial period ending June 30, 1993, the following:

1 SECTION 2. APPROPRIATIONS. There is hereby appropriated, to the
2 Department of Finance and Administration - Disbursing Officer, to be payable
3 from the Work Force 2000 Development Fund, for accreditation purposes as
4 authorized in Section 6(c) of Act 1246 of 1991 for the various technical
5 institutes and comprehensive lifelong learning centers which shall be
6 supplemental and in addition to those funds appropriated in Section 1 of Act
7 1246 of 1991, for the remainder of the biennial period ending June 30, 1993,
8 the following:

14 SECTION 3. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
15 authorized by this Act shall be limited to the appropriation for such agency
16 and funds made available by law for the support of such appropriations; and
17 the restrictions of the State Purchasing Law, the General Accounting and
18 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
19 Procedures and Restrictions Act, or their successors, and other fiscal control
20 laws of this State, where applicable, and regulations promulgated by the
21 Department of Finance and Administration, as authorized by law, shall be
22 strictly complied with in disbursement of said funds.

23

24 SECTION 4. LEGISLATIVE INTENT. It is the intent of the General
25 Assembly that any funds disbursed under the authority of the appropriations
26 contained in this Act shall be in compliance with the stated reasons for which
27 this Act was adopted, as evidenced by the Agency Requests, Executive
28 Recommendations and Legislative Recommendations contained in the budget
29 manuals prepared by the Department of Finance and Administration, letters, or
30 summarized oral testimony in the official minutes of the Arkansas Legislative
31 Council or Joint Budget Committee which relate to its passage and adoption.

32

33 SECTION 5. CODE. All provisions of this Act of a general and permanent
34 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
35 Code Revision Commission shall incorporate the same in the Code.

2 SECTION 6. SEVERABILITY. If any provision of this Act or the
3 application thereof to any person or circumstance is held invalid, such
4 invalidity shall not affect other provisions or applications of the Act which
5 can be given effect without the invalid provision or application, and to this
6 end the provisions of this Act are declared to be severable.

7

8 SECTION 7. GENERAL REPEALER. All laws and parts of laws in conflict
9 with this Act are hereby repealed.

10

11 SECTION 8. EMERGENCY CLAUSE. It is hereby found and determined by the
12 Seventy-Ninth General Assembly meeting in Regular Session, that funds provided
13 by the Seventy-Eighth General Assembly for the operations of the Department of
14 Finance and Administration - Disbursing Officer are, due to unforeseen
15 circumstances, insufficient for the Department of Finance and Administration -
16 Disbursing Officer to continue to provide essential governmental services;
17 that the provisions of this act will provide the necessary monies for the
18 Department of Finance and Administration - Disbursing Officer to continue such
19 services; and that a delay in the effective date of this Act could work
20 irreparable harm upon the proper administration and provision of essential
21 governmental programs. Therefore, an emergency is hereby declared to exist
22 and this Act being necessary for the immediate preservation of the public
23 peace, health and safety shall be in full force and effect from and after the
24 date of its passage and approval.
