HOUSE BILL 1522

For An Act To Be Entitled

8 "AN ACT TO MAKE AN APPROPRIATION TO THE ARKANSAS GAME AND
9 FISH COMMISSION FOR PUBLISHING ADDITIONAL COPIES OF THE
10 BEGINNER'S FISHING GUIDE FOR THE BIENNIAL PERIOD ENDING
11 JUNE 30, 1993; AND FOR OTHER PURPOSES."

Subtitle

14 "AN ACT FOR THE ARKANSAS GAME AND FISH COMMISSION
15 APPROPRIATION."

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

19 SECTION 1. APPROPRIATIONS. There is hereby appropriated, to the
20 Arkansas Game and Fish Commission, to be payable from the *State General*
21 *Services Fund Account* for matching federal funds of the Arkansas Game and Fish
22 Commission to be used to publish three thousand two hundred and fifty (3,250)
23 copies of the Beginner's Fishing Guide, for the biennial period ending June
24 30, 1993, the sum of
25\$1,250.00.

27 SECTION 2. *It is the intent of the General Assembly that any future*
28 *appropriations enacted and made payable from State General Revenues for the*
29 *benefit of the Arkansas Game and Fish Commission shall be from new General*
30 *Revenues raised by the General Assembly.*

32 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General Assembly
33 that any funds disbursed under the authority of the appropriations contained
34 in this Act shall be in compliance with the stated reasons for which this Act
35 was adopted, as evidenced by the Agency Requests, Executive Recommendations

1 and Legislative Recommendations contained in the budget manuals prepared by
2 the Department of Finance and Administration, letters, or summarized oral
3 testimony in the official minutes of the Arkansas Legislative Council or Joint
4 Budget Committee which relate to its passage and adoption.

6 SECTION 4. CODE. All provisions of this Act of a general and permanent
7 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
8 Code Revision Commission shall incorporate the same in the Code.

9

10 SECTION 5. SEVERABILITY. If any provision of this Act or the
11 application thereof to any person or circumstance is held invalid, such
12 invalidity shall not affect other provisions or applications of the Act which
13 can be given effect without the invalid provision or application, and to this
14 end the provisions of this Act are declared to be severable.

15

16 SECTION 6. GENERAL REPEALER. All laws and parts of laws in conflict
17 with this Act are hereby repealed.

18

19 SECTION 7. EMERGENCY CLAUSE. It is hereby found and determined by the
20 Seventy-Ninth General Assembly, that in order to access federal funds for
21 making Beginner's Fishing Guides available to the public, State matching funds
22 are needed. Therefore, an emergency is hereby declared to exist and this Act
23 being necessary for the immediate preservation of the public peace, health and
24 safety shall be in full force and effect from and after its passage and
25 approval.
