## 7 **For An Act To Be Entitled**

8 "AN ACT TO AMEND ARKANSAS CODE ANNOTATED §§ 9-14-206(d) TO  
9 REMOVE THE STATISTICAL LIMITATION ON THE NUMBER OF  
10 COUNTIES IN WHICH THE MANAGER OF THE CHILD SUPPORT  
11 ENFORCEMENT UNIT MAY APPOINT CHILD SUPPORT OFFICERS; AND  
12 FOR OTHER PURPOSES."

## 14 **Subtitle**

15 "AN ACT TO REMOVE THE STATISTICAL LIMITATION ON THE NUMBER  
16 OF COUNTIES IN WHICH THE MANAGER OF THE CHILD SUPPORT  
17 ENFORCEMENT UNIT MAY APPOINT CHILD SUPPORT OFFICERS."

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20

21 SECTION 1. Arkansas Code Annotated § 9-14-206(d) is hereby amended to  
22 read as follows:

23 "(d) The Child Support Enforcement Unit is hereby designated as a law  
24 enforcement agency and, upon notice to the sheriff of any affected county, may  
25 employ a child support officer to assist in the service of civil and criminal  
26 process and to enforce child support orders in this state. Such officers  
27 shall be duly certified law enforcement officers pursuant to § 12-9-101 et  
28 seq. and shall have the same power to execute, serve, and return all lawful  
29 warrants including warrants of arrest issued by the State of Arkansas or any  
30 political subdivision thereof."

32 SECTION 2. Arkansas Code Annotated §9-14-207(b) is repealed.

33

34 SECTION 3. All provisions of this act of a general and permanent nature  
35 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code

1 Revision Commission shall incorporate the same in the Code.

2

3 SECTION 4. If any provision of this act or the application thereof to  
4 any person or circumstance is held invalid, such invalidity shall not affect  
5 other provisions or applications of the act which can be given effect without  
6 the invalid provision or application, and to this end the provisions of this  
7 act are declared to be severable.

8

9 SECTION 5. All laws and parts of laws in conflict with this act are  
10 hereby repealed.
