## 7 **For An Act To Be Entitled**

8 "AN ACT TO AMEND ARKANSAS CODE 26-36-203 RELATING TO THE  
9 PREPARATION AND PUBLICATION OF THE DELINQUENT PERSONAL  
10 PROPERTY LIST, FORM OF THE PUBLICATION, FEES FOR  
11 PREPARATION AND PUBLICATION OF THE LIST; AND FOR OTHER  
12 PURPOSES."

## 14 **Subtitle**

15 "PUBLICATION OF DELINQUENT PERSONAL PROPERTY TAX LIST."

16

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

18

19 SECTION 1. Arkansas Code 26-36-203 is amended to read as follows:  
20 "26-36-203. Publication of delinquent personal property tax list.  
21 (a) No later than December 1 in each year, the collector of taxes shall  
22 prepare a list of delinquent personal property taxes and deliver a copy of the  
23 list to a legal newspaper of the county. Within seven (7) days thereafter,  
24 the newspaper shall publish the first insertion of the list, which shall be  
25 published two (2) times in successive weeks. The newspaper shall publish the  
26 list in at least seven (7) point size type. If the newspaper regularly  
27 publishes a Total Market Coverage Edition or Supplement Publication that has  
28 wider circulation within the county or district, the newspaper may publish the  
29 list one (1) of the required two (2) times in said edition or publication. If  
30 there is no newspaper in the county or district, the publication shall be in  
31 the nearest newspaper having a general circulation in the county or districts  
32 for which the list is being published.

33 (b) The publication shall show, besides the name of the taxpayer, his  
34 school district and the total amount of taxes delinquent, including penalties.  
35 The publication shall be in substance as follows:
