## 7 **For An Act To Be Entitled**

8 "AN ACT TO AMEND ARKANSAS CODE 27-16-907 TO ALLOW THE  
9 SUSPENSION OR REVOCATION OF A DRIVER\_S LICENSE WHERE THE  
10 DRIVER HAS BEEN INVOLVED IN AN ACCIDENT CAUSED BY THE  
11 DRIVER\_S LOSS OF CONSCIOUSNESS OR BLACKOUT; AND FOR OTHER  
12 PURPOSES."

## 14 **Subtitle**

15 "TO EXPAND THE CRITERIA FOR THE SUSPENSION OR REVOCATION  
16 OF A DRIVER\_S LICENSE."

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

19

20 SECTION 1. Arkansas Code 27-16-907(a) is amended to read as follows:  
21 "27-16-907. Suspension or revocation of licenses.

22 (a) The office is authorized to suspend the license of an operator or  
23 chauffeur without preliminary hearing upon a showing by its records or other  
24 sufficient evidence that the licensee:

25 (1) Has been convicted of an offense for which mandatory  
26 revocation of license is required;

27 (2) Has been involved as a driver in any accident resulting in  
28 the death or personal injury of another or serious property damage;

29 (3) Has been involved as a driver in any accident caused by the  
30 driver\_s lapse of consciousness or blackout or any other medical condition  
31 that could affect the driver\_s ability to safely drive a motor vehicle;

32 (4) Is an habitually reckless or negligent driver of a motor  
33 vehicle;

34 (5) Is an habitual violator of the traffic laws;

35 (6) Is incompetent to drive a motor vehicle;

- (7) Has permitted an unlawful or fraudulent use of his license;
- (8) Has committed an offense in another state which, if committed in this state, would be grounds for suspension or revocation; or
- (9) Is receiving any type of welfare, tax, or other benefit or exemption as a blind or nearly blind person, if the correctable vision of the person is less than 20/50 in the better eye or if the total visual field of the person is less than one hundred and five degrees ( $105^\circ$ )."

9 SECTION 2. All provisions of this act of a general and permanent nature  
10 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code  
11 Revision Commission shall incorporate the same in the Code.

13 SECTION 3. If any provision of this act or the application thereof to  
14 any person or circumstance is held invalid, such invalidity shall not affect  
15 other provisions or applications of the act which can be given effect without  
16 the invalid provision or application, and to this end the provisions of this  
17 act are declared to be severable.

18

19 SECTION 4. All laws and parts of laws in conflict with this act are  
20 hereby repealed.
