## 9 **For An Act To Be Entitled**

10 "AN ACT TO REQUIRE THE DIRECTORS OF THE DEPARTMENT OF  
11 EDUCATION, THE DEPARTMENT OF HIGHER EDUCATION, THE  
12 VOCATIONAL AND TECHNICAL EDUCATION DIVISION AND THE  
13 ARKANSAS INDUSTRIAL DEVELOPMENT COMMISSION TO MEET NOT  
14 LESS THAN ONCE EVERY SIX MONTHS TO DISCUSS THE EDUCATIONAL  
15 NEEDS OF ARKANSAS INDUSTRY; AND FOR OTHER PURPOSES."

## 17 **Subtitle**

18 "DIRECTORS OF EDUCATION, HIGHER EDUCATION, THE VOCATIONAL  
19 AND TECHNICAL EDUCATION DIVISION AND AIDC TO MEET TOGETHER  
20 SEMI-ANNUALLY."

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23

24 SECTION 1. The directors of the Arkansas Industrial Development  
25 Commission, the Department of Education, the Department of Higher Education  
26 and the Vocational and Technical Education Division shall meet not less than  
27 once every six (6) months to discuss the educational needs of the industries  
28 in the state, how those needs are being met by the educational institutions  
29 located in the state and any legislation which should be implemented to  
30 further the educational needs of the industries in this state. The directors  
31 shall file a report on the meeting with the Governor and the Joint Interim  
32 Committee on Agriculture and Economic Development which shall include the  
33 minutes of the meeting and the directors attending.

34

35 SECTION 2. All provisions of this act of a general and permanent

1 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas  
2 Code Revision Commission shall incorporate the same in the Code.

3

4 SECTION 3. If any provision of this act or the application thereof to  
5 any person or circumstance is held invalid, such invalidity shall not affect  
6 other provisions or applications of the act which can be given effect without  
7 the invalid provision or application, and to this end the provisions of this  
8 act are declared to be severable.

9

10 SECTION 4. All laws and parts of laws in conflict with this act are  
11 hereby repealed.
