## 7 **For An Act To Be Entitled**

8 "AN ACT TO AMEND ARKANSAS CODE 27-35-304 AND 27-35-306 TO  
9 PROVIDE THAT NO SPECIAL PERMIT SHALL BE ISSUED FOR  
10 TRANSPORTING A MANUFACTURED HOME IN EXCESS OF EIGHTEEN  
11 (18) FEET IN WIDTH; AND FOR OTHER PURPOSES."

## 13 **Subtitle**

14 "NO SPECIAL PERMIT SHALL BE ISSUED FOR TRANSPORTING A  
15 MANUFACTURED HOME IN EXCESS OF 18 FEET IN WIDTH."

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

18

19 SECTION 1. Arkansas Code 27-35-304 is amended to read as follows:  
20 "§27-35-304. Special permit to move - Fee.

21 (a) (1) Manufactured home units may be lawfully moved interstate and  
22 intrastate on the highways, roads, and streets of this state by procuring a  
23 special permit issued by the department.

24 (2) A permit shall be required for each single continuous  
25 movement of each manufactured home unit.

26 (3) No special permit shall be issued for any manufactured home  
27 unit exceeding eighteen feet (18\_) in width inclusive of clearance lights or  
28 eaves.

29 (b) Special permits required under this subchapter may be obtained from  
30 any department weigh station or the central offices of the department, and the  
31 department shall charge a fee of ten dollars (\$10.00) for the permit, provided  
32 the manufactured home unit to be moved does not exceed sixteen feet (16') in  
33 width inclusive of clearance lights or eaves. The department shall charge a  
34 fee of no more than one hundred fifty dollars (\$150.00) if the manufactured  
35 home to be moved is greater than sixteen feet (16') in width inclusive of

1 clearance lights or eaves but does not exceed eighteen feet (18') in width  
2 inclusive of clearance lights or eaves."

3

4 SECTION 2. Subsection (b) of Arkansas Code 27-35-306 is hereby amended  
5 to read as follows:

6 "(b) The department shall not issue any permits for the movement of a  
7 manufactured home unit over any highway, road or street, which movement, in  
8 the opinion of the department, would endanger the traveling public or would  
9 potentially damage any structures or signs on or adjacent to any highway, road  
10 or street."

11

12 SECTION 3. All provisions of this act of a general and permanent nature  
13 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code  
14 Revision Commission shall incorporate the same in the Code.

15

16 SECTION 4. If any provision of this act or the application thereof to  
17 any person or circumstance is held invalid, such invalidity shall not affect  
18 other provisions or applications of the act which can be given effect without  
19 the invalid provision or application, and to this end the provisions of this  
20 act are declared to be severable.

21

22 SECTION 5. All laws and parts of laws in conflict with this act are  
23 hereby repealed.
