## 7 **For An Act To Be Entitled**

8 "AN ACT TO TRANSFER THE ARKANSAS LIVESTOCK AND POULTRY-  
9 COMPLIANCE UNIT AND ALL POWERS, FUNCTIONS AND DUTIES AND  
10 ALL VEHICLES AND EQUIPMENT OF THAT UNIT TO THE ARKANSAS  
11 STATE POLICE; AND FOR OTHER PURPOSES."

## 13 **Subtitle**

14 "TRANSFERRING THE LIVESTOCK AND POULTRY-COMPLIANCE UNIT TO  
15 THE ARKANSAS STATE POLICE."

16

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

18

19 SECTION 1. Effective July 1, 1993, the Arkansas Livestock and Poultry  
20 Commission-Compliance Unit is hereby transferred to the Arkansas State Police.  
21 The Compliance Unit shall retain all powers, functions and duties now  
22 exercised by it but such powers, functions and duties shall be performed under  
23 the supervision of the head of the Arkansas State Police.

24

25 SECTION 2. All fees, fines, penalties and forfeitures collected  
26 pursuant to the activities of the Compliance Unit shall be used exclusively  
27 for salaries, maintenance and operation of the Unit.

28

29 SECTION 3. All records, personnel, property, unexpended balances of  
30 appropriations, allocations, or other funds, and the functions of budgeting  
31 and purchasing are transferred to the Arkansas State Police.

32

33 SECTION 4. It is the intent of this act that the Compliance Unit of the  
34 Arkansas Livestock and Poultry Commission which is transferred to the Arkansas  
35 State Police Department shall continue to perform the same functions and

1 duties of policing and enforcing the laws and rules and regulations of the  
2 Livestock and Poultry Commission as it performed prior to its transfer and  
3 that such Unit and the functions it performs hereafter be under the  
4 supervision and direction of the Director of Arkansas State Police.

5

6 SECTION 5. Any and all personnel authorized and appropriations made to  
7 the Livestock and Poultry Commission for salaries, maintenance and operation  
8 or other purposes of the Compliance Unit for the 1993-95 biennium shall be  
9 transferred and made available to the Department of Arkansas State Police to  
10 be used for salaries, maintenance and operation of the Compliance Unit hereby  
11 transferred to the Department of State Police.

12

13 SECTION 6. All provisions of this act of a general and permanent nature  
14 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code  
15 Revision Commission shall incorporate the same in the Code.

16

17 SECTION 7. If any provision of this act or the application thereof to  
18 any person or circumstance is held invalid, such invalidity shall not affect  
19 other provisions or applications of the act which can be given effect without  
20 the invalid provision or application, and to this end the provisions of this  
21 act are declared to be severable.

22

23 SECTION 8. All laws and parts of laws in conflict with this act are  
24 hereby repealed.
