## 7   **For An Act To Be Entitled**

8       "AN ACT TO AMEND ARKANSAS CODE § 27-20-202 TO AUTHORIZE  
9       THE DEPARTMENT OF FINANCE AND ADMINISTRATION TO REGISTER  
10      ANY ALL-TERRAIN VEHICLE WHOSE OWNER CANNOT PROVIDE PROOF  
11      OF OWNERSHIP IF THE OWNER POSTS A BOND EQUAL TO AT LEAST  
12      ONE AND ONE-HALF (1-1/2) TIMES THE MARKET VALUE OF THE  
13      ALL-TERRAIN VEHICLE; AND FOR OTHER PURPOSES."

## **Subtitle**

16       "AN ACT TO AUTHORIZE THE DEPARTMENT OF FINANCE AND  
17       ADMINISTRATION TO REGISTER ANY ALL-TERRAIN VEHICLE WHOSE  
18       OWNER CANNOT PROVIDE PROOF OF OWNERSHIP."

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22       SECTION 1. Arkansas Code § 27-20-202 is hereby amended to read as  
23 follows:

24       "27-20-202. Registration required.

25           (a) All owners of three (3) or four (4) wheeled all-terrain cycles  
26 which are not otherwise required to be registered by law shall, within ten  
27 (10) days of acquiring such three (3) or four (4) wheeled cycles, register  
28 them with the Director of the Department of Finance and Administration.

29           (b) The owners shall offer proof of ownership satisfactory to the  
30 department. If the person seeking to register the all-terrain cycle cannot  
31 offer satisfactory proof of ownership, the department may register the all-  
32 terrain cycle if the person seeking registration posts a bond equal to at  
33 least one and one-half (1-1/2) times the market value of the all-terrain  
34 cycle. The bond shall be a cash bond, or a letter of credit, a surety bond  
35 issued by a fidelity or surety company authorized to do business in Arkansas,

1 or a personal bond signed by at least two (2) property owners in this state.  
2 The bond shall be for a period of three (3) years and made payable to the  
3 Department of Finance and Administration to be used by the department to pay  
4 any valid claim arising from the disputed ownership of the all-terrain cycle.

5 (c) The cost of registration shall be five dollars (\$5.00)."

7 SECTION 2. All provisions of this act of general and permanent nature  
8 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code  
9 Revision Commission shall incorporate the same in the Code.

10

11 SECTION 3. If any provisions of this act or the application thereof to  
12 any person or circumstance is held invalid, the invalidity shall not affect  
13 other provisions or applications of the act which can be given effect without  
14 the invalid provisions or application, and to this end the provisions of this  
15 act are declared to be severable.

16

17 SECTION 4. All laws and parts of laws in conflict with this act are  
18 hereby repealed.
