8 "AN ACT TO AMEND ARKANSAS CODE 25-23-103 RELATING TO THE
9 MEMBERSHIP OF THE QUALITY MANAGEMENT BOARD; AND FOR OTHER
10 PURPOSES . "

12 **Subtitle**

13 "ESTABLISHING MEMBERSHIP OF THE QUALITY MANAGEMENT BOARD."

14

15 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

16

17 SECTION 1. Arkansas Code 25-23-103 is amended to read as follows:

18 "25-23-103. Creation - Members - Meetings.

19 (a) There is hereby created the Quality Management Board.

20 (b) The board shall consist of seven (7) members.

21 (1) (A) Four (4) members of the board shall be appointed by the
22 Governor.

23 (B) Their successors shall be appointed for terms of three (3)
24 years.

25 (2) One (1) member of the board shall be appointed from recommendation
26 of A.S.E.A.

27 (3) One (1) member of the board shall be appointed from the House of
28 Representatives by the Speaker of the House.

29 (4) One (1) member of the board shall be appointed from the Senate by
30 the President Pro Tempore of the Senate.

31 (5) The Chief Fiscal Officer of the State shall serve as an ex officio
32 member of the board.

33 (6) Members of the board shall serve at the pleasure of the Governor.

34 (7) Should a vacancy occur on the board, such vacancy shall be filled
35 in the same manner as the original appointment, within thirty (30) days of

1 occurrence.

2 (c) (1) Meetings shall be scheduled every sixty (60) days to avoid
3 unnecessary delays in the process."

4 (2) Additional meetings may be held at the discretion of the
5 chairperson or upon request of any three (3) members of the board.

6 (3) Reasonable notice of all meetings shall be given in the manner
7 prescribed by the laws of this state, and all meetings of the board shall be
8 open to the public.

9 (4) A quorum of the board shall consist of three (3) members.

10 (d) The board shall elect a chairperson.

11 (e) The Chief Fiscal Officer of the State shall provide staffing for
12 the board."

13

14 SECTION 2. All provisions of this act of a general and permanent nature
15 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
16 Revision Commission shall incorporate the same in the Code.

17

18 SECTION 3. If any provision of this act or the application thereof to
19 any person or circumstance is held invalid, such invalidity shall not affect
20 other provisions or applications of the act which can be given effect without
21 the invalid provision or application, and to this end the provisions of this
22 act are declared to be severable.

23

24 SECTION 4. All laws and parts of laws in conflict with this act are
25 hereby repealed.
