## For An Act To Be Entitled

8 "AN ACT TO ABOLISH THE OFFICE OF STATE PRINTING CLERK  
9 LOCATED IN THE OFFICE OF THE AUDITOR OF STATE; TO AMEND  
10 ARKANSAS CODE §25-18-302(a) TO SUBSTITUTE THE OFFICE OF  
11 STATE PURCHASING FOR ACCOMPLISHMENT OF CERTAIN DUTIES OF THE  
12 STATE PRINTING CLERK; AND FOR OTHER PURPOSES."

### Subtitle

15 "AN ACT TO ABOLISH THE OFFICE OF STATE PRINTING CLERK  
16 LOCATED IN THE OFFICE OF THE AUDITOR OF STATE."

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

19

20 SECTION 1. Arkansas Code §25-18-302 (a) is amended to read as follows:  
21 "(a) Each department or division of the state under whose jurisdiction  
22 any document is issued is authorized and directed to send to the Mullins  
23 Library of the University of Arkansas at Fayetteville twenty (20) copies of all  
24 such documents or publications. This requirement may be waived or the number  
25 of copies required reduced upon instructions of the university librarian to the  
26 Office of State Purchasing and the state agency issuing the publication. Only  
27 three (3) copies of all mimeographed or near-print publications, other than  
28 annual or biennial reports, shall be sent to the library unless other copies  
29 are specifically requested by the librarian."

30

31 SECTION 2. (a) Arkansas Code §19-11-101 and §25-18-303 are hereby  
32 repealed.

33 (b) All other laws or parts of laws in conflict with this act are hereby  
34 repealed.

35

1 SECTION 3. All provisions of this act of a general and permanent nature  
2 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code  
3 Revision Commission shall incorporate the same in the Code.

5 SECTION 4. If any provision of this act or the application thereof to  
6 any person or circumstance is held invalid, such invalidity shall not affect  
7 other provisions or applications of the act which can be given effect without  
8 the invalid provision or application, and to this end the provisions of this  
9 act are declared to be severable.
