8 "AN ACT TO MAKE AN APPROPRIATION FOR DISTRIBUTION OF COURT COSTS
9 FOR THE OFFICE OF THE TREASURER OF STATE FOR THE BIEENNIAL PERIOD
10 ENDING JUNE 30, 1995; AND FOR OTHER PURPOSES."

13 "AN ACT FOR THE OFFICE OF THE TREASURER OF STATE APPROPRIATION TO
14 DISTRIBUTE COURT COSTS."

16 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

18 SECTION 1. APPROPRIATIONS. There is hereby appropriated, to the Office of the Treasurer of State, to be payable
19 from the Administration of Justice Account, to distribute court costs received by the Office of the Treasurer of State for the biennial period
20 ending June 30, 1995, the following:

26 SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this Act shall be limited to
27 the appropriation for such agency and funds made available by law for the support of such appropriations; and the restrictions of the State
28 Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures
29 and Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by the
30 Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of said funds.

32 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the
33 authority of the appropriations contained in this Act shall be in compliance with the stated reasons for which this Act was adopted, as evidenced
34 by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the
35 Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or

1 Joint Budget Committee which relate to its passage and adoption.

3 **SECTION 4. CODE.** All provisions of this Act of a general and permanent nature are amendatory to the Arkansas Code of
4 1987 Annotated and the Arkansas Code Revision Commission shall incorporate the same in the Code.

6 **SECTION 5. SEVERABILITY.** If any provision of this Act or the application thereof to any person or circumstance is held
7 invalid, such invalidity shall not affect other provisions or applications of the Act which can be given effect without the invalid provision or
8 application, and to this end the provisions of this Act are declared to be severable.

10 **SECTION 6. GENERAL REPEALER.** All laws and parts of laws in conflict with this Act are hereby repealed.

12 **SECTION 7. EMERGENCY CLAUSE.** It is hereby found and determined by the Seventy-Ninth General Assembly, that
13 the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a two (2) year period; that the effectiveness of this
14 Act on July 1, 1993 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an
15 extension of the Regular Session, the delay in the effective date of this Act beyond July 1, 1993 could work irreparable harm upon the proper
16 administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being
17 necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 1993.
