8 "AN ACT TO ABOLISH THE SENIORITY SYSTEM IN THE HOUSE IN
9 ACCORDANCE WITH THE TERM LIMITATION AMENDMENT."

Subtitle

12 "TO ABOLISH THE SENIORITY SYSTEM IN THE HOUSE IN ACCORDANCE
13 WITH THE TERM LIMITATION AMENDMENT."

14

15 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

16

17 SECTION 1. Beginning with the Eightieth General Assembly and
18 notwithstanding any rule or law to the contrary, the present seniority system
19 in the House of Representatives is hereby abolished and the present membership
20 of all Standing, Select and Joint Committees of the House is abolished. The
21 membership to all Standing Committees of the House shall be selected by lot,
22 except that members may trade committee memberships at will. After the General
23 Election but prior to the convening of the next regular session, the House of
24 Representatives shall caucus and each member shall draw a number of between one
25 (1) and one hundred (100) by lot. The person with number one (1) shall choose
26 his membership on one (1) Standing Committee, and the rest of the membership
27 shall choose membership on one (1) committee until all one hundred (100)
28 members have chosen their membership on one (1) committee. The process shall
29 be repeated until the membership of all Standing Committees has been
30 determined. The members of each committee shall select their chairman and vice
31 chairman. All bills pending in the House on the effective date of this act
32 shall be referred back to committees whose membership were selected under this
33 act.

35 SECTION 2. All provisions of this act of a general and permanent nature

1 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
2 Revision Commission shall incorporate the same in the Code.

3

4 SECTION 3. If any provision of this act or the application thereof to
5 any person or circumstance is held invalid, such invalidity shall not affect
6 other provisions or applications of the act which can be given effect without
7 the invalid provision or application, and to this end the provisions of this
8 act are declared to be severable.

9

10 SECTION 4. All laws and parts of laws in conflict with this act are
11 hereby repealed.

12

13 SECTION 5. EMERGENCY. It is hereby found and determined by the General
14 Assembly that due to the term limitation amendment to the Arkansas Constitution
15 the membership of House committees should immediately be determined without
16 regard to seniority; that such action must occur as soon as possible in order
17 to avoid delaying the work of the Seventy-Ninth General Assembly; and that this
18 act so provides. Therefore, an emergency is hereby declared to exist and this
19 act being necessary for the immediate preservation of the public peace, health
20 and safety shall be in full force and effect from and after its passage and
21 approval.
