HOUSE BILL

For An Act To Be Entitled

8 "AN ACT TO AMEND TITLE 6, CHAPTER 64, SUBCHAPTER 6 OF THE
9 ARKANSAS CODE OF 1987, ANNOTATED TO LIMIT THE NUMBER OF
10 FULL-TIME LAW STUDENTS TO BE ADMITTED TO THE UNIVERSITY OF
11 ARKANSAS, SCHOOLS OF LAW TO THE SAME NUMBER OF FULL-TIME
12 MEDICAL STUDENTS ADMITTED TO THE UNIVERSITY OF ARKANSAS
13 FOR MEDICAL SCIENCES; AND FOR OTHER PURPOSES."

16 "AN ACT TO LIMIT THE NUMBER OF FULL-TIME LAW STUDENTS TO
17 BE ADMITTED TO THE UNIVERSITY OF ARKANSAS TO THE SAME
18 NUMBER OF FULL-TIME MEDICAL STUDENTS."

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22 SECTION 1. Title 6, Chapter 64, Subchapter 6 of the Arkansas Code of
23 1987, Annotated, is hereby amended to add a new Section to read as follows:

24 "6-64-622. Law school admissions - Limitations.

25 (a) Beginning with the 1994-95 academic year, the University of
26 Arkansas at Little Rock, School of Law and the School of Law of the University
27 of Arkansas at Fayetteville shall be limited in the number of law students
28 which they can admit to the full-time course of study in legal instruction.
29 Both institutions shall be limited to admitting as full-time law students the
30 same number of full-time medical students admitted to the University of
31 Arkansas for Medical Sciences.

32 (b) The President of the University of Arkansas is hereby delegated the
33 authority to determine the total number of full-time law students to be
34 admitted to the University and the number to be admitted to each School of
35 Law. Nothing in this section shall be construed to limit the discretion of

1 the President in allocating the number of full-time law students per each
2 School of Law.

3 (c) The President of the University of Arkansas shall have the
4 authority to promulgate any and all necessary rules, regulations, policies,
5 and guidelines in order to carry out the purposes of this section."
6

7 SECTION 2. Arkansas Code § 6-64-602 is hereby amended to read as
8 follows:

9 "6-64-602. Establishment - Name.

10 (a) There is established a full-time law school, to be operated in
11 Little Rock, Pulaski County, Arkansas, under the control and direction of the
12 University of Arkansas at Little Rock, to be known as the _School of Law,
13 University of Arkansas at Little Rock,_ and to offer classes of legal
14 instruction both in the daytime and in the evening.

15 (b) The number of law students admitted to the University of Arkansas
16 at Little Rock, School of Law shall be regulated by the powers and policies
17 delegated to the President of the University of Arkansas in accordance with
18 the provisions of Arkansas Code § 6-64-622."

20 SECTION 3. All provisions of this act of general and permanent nature
21 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
22 Revision Commission shall incorporate the same in the Code.
23

24 SECTION 4. If any provisions of this act or the application thereof to
25 any person or circumstance is held invalid, the invalidity shall not affect
26 other provisions or applications of the act which can be given effect without
27 the invalid provisions or application, and to this end the provisions of this
28 act are declared to be severable.
29

30 SECTION 5. All laws and parts of laws in conflict with this act are
31 hereby repealed.
