15 RECOGNIZING THE LITTLE ROCK FIELD OFFICE OF THE FEDERAL
16 BUREAU OF ALCOHOL, TOBACCO AND FIREARMS AND THE MEMBERS
17 WHO SERVED ON THE SPECIAL RESPONSE TEAM.

20 WHEREAS, the Little Rock field office of the federal Bureau of Alcohol,
21 Tobacco and Firearms is assigned eleven special agents; and

22

23 WHEREAS, five of the Little Rock-based agents were assigned to the
24 Special Response Team sent to Waco, Texas, to search the Branch Davidian
25 complex for federal firearms violations; and

26

27 WHEREAS, four agents of the Bureau of Alcohol, Tobacco and Firearms were
28 killed in the raid and fifteen others were wounded; and

29

30 WHEREAS, of the five Little Rock-based special agents assigned to the
31 raid on the compound in Waco, Texas, one was killed and three others were
32 injured; and

34 WHEREAS, Agent Robert J. Williams, 26, of Little Rock gave his life in
35 the service of his country; and

2 WHEREAS, the Little Rock-based agents injured in the line of duty are:
3 Bill Buford, resident agent-in-charge of the Little Rock field office, W. Glen
4 Jordan of Little Rock and Clay Alexander of Maumelle; and
5

6 WHEREAS, the Little Rock field office of the federal Bureau of Alcohol,
7 Tobacco and Firearms and, in particular, the five Little Rock-based agents who
8 served on the Special Response Team should be commended for dedication to
9 service, enforcement of the laws of our country, and the protection of the
10 citizens of this state and country.

12 NOW THEREFORE,

13 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE SEVENTY-NINTH GENERAL
14 ASSEMBLY OF THE STATE OF ARKANSAS:

16 THAT, the members of the House of Representatives of the Arkansas
17 General Assembly hereby recognize the Little Rock field office of the federal
18 Bureau of Alcohol, Tobacco and Firearms for its dedication to service,
19 enforcement of the laws of our country, and the protection of the citizens of
20 this state and country and to recognize the five members of the Little Rock
21 office who served as members of the Special Response Team for their dedication
22 to duty, their acts of service and heroism, and their service above and beyond
23 the call of duty.

26 of the Arkansas General Assembly hereby express their sympathy to the family
27 of Agent Robert J. Williams.
