13 JOINT INTERIM COMMITTEE ON INSURANCE AND COMMERCE TO
14 CONDUCT A COMPREHENSIVE STUDY OF THE VARIOUS FILING
15 SYSTEMS FOR FARM PRODUCT LIENS.

17 WHEREAS, Section 1324 of the Federal Food Security Act of 1985 [Public
18 Law 99-198] grants clear title to all buyers of grain, livestock, poultry and
19 other agricultural commodities; and

20 WHEREAS, under the federal law, states have the option of implementing
21 two methods of notifying potential buyers of farm products of the existence of
22 liens; through the means of direct notification and through means of
23 establishing a central filing system within the Secretary of State's Office;
24 and

25 WHEREAS, the Arkansas General Assembly enacted legislation in 1986 to
26 create a central filing system in the Office of the Secretary of State and to
27 repeal this office by Act 655 of 1989; and

28 WHEREAS, the Joint Interim Committee on Insurance and Commerce is the
29 proper committee to conduct a comprehensive review and to determine the
30 feasibility of enacting a central filing system.

32 NOW THEREFORE,

33 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE SEVENTY-NINTH GENERAL
34 ASSEMBLY OF THE STATE OF ARKANSAS:

35

1 THAT the Joint Interim Committee on Insurance and Commerce conduct a
2 comprehensive review of the eighteen (18) states which have a United States
3 Department of Agriculture Certified Central Filing System.

5 BE IT FURTHER RESOLVED

6 THAT the Joint Interim Committee is urged to create a subcommittee to
7 meet jointly with an ad hoc committee of interested groups, including but not
8 limited to, representatives of State Farm Bureau, the Arkansas Cattlemen's
9 Association, the Independent Bankers Association, the Arkansas Bankers
10 Association, the Arkansas Association of Bank Holding Companies, and the
11 Office of the Secretary of State.
