27 WHEREAS, President Clinton has nominated Mr. Rodney E. Slater to be the  
28 Administrator of the Federal Highway Administration; and

29 WHEREAS, Mr. Slater is currently the Chairman of the Arkansas Highway  
30 Commission; and

31 WHEREAS, Mr. Slater is unquestionably qualified to assume the position  
32 of Administrator of the Federal Highway Administration; and

34 as an Assistant Attorney General for the State of Arkansas, as well as serving
