## For An Act To Be Entitled

7 "AN ACT TO AMEND ARKANSAS CODE § 27-14-703 TO EXEMPT  
8 MOBILE HOMES FROM THE REQUIREMENTS OF RENEWAL OF  
9 REGISTRATION; TO AMEND ARKANSAS CODE § 27-14-1602 TO  
10 PROVIDE FOR THE NONRENEWABLE REGISTRATION OF MOBILE HOMES  
11 AND TO REMOVE THE FEE FROM THE REGISTRATION OF MOBILE  
12 HOMES; AND FOR OTHER PURPOSES."

## Subtitle

15 "AN ACT TO EXEMPT MOBILE HOMES FROM THE RENEWAL  
16 REQUIREMENTS OF REGISTRATION AND TO REMOVE THE FEES LEVIED  
17 FOR REGISTRATION OF MOBILE HOMES."

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21

22 SECTION 1. Arkansas Code § 27-14-703 is hereby amended to read as  
23 follows:

24 "27-14-703. Vehicles subject to registration - Exceptions. Every motor  
25 vehicle, trailer, semitrailer, and pole trailer when driven or moved upon a  
26 highway and every mobile home shall be subject to the provisions of this  
27 chapter except:

28 (1) Any vehicle driven or moved upon a highway in conformance with the  
29 provisions of this chapter relating to manufacturers, transporters, dealers,  
30 lienholders, or nonresidents or under a temporary registration permit issued  
31 by the office as authorized in § 27-14-708;

32 (2) Any vehicle which is driven or moved upon a highway only for the  
33 purpose of crossing such highway from one (1) property to another;

34 (3) Any implement of husbandry whether of a type otherwise subject to  
35 registration under this chapter or not which is only incidentally operated or

1 moved upon a highway;

2 (4) Any special mobile equipment as defined in § 27-14-211;

3 (5) Any vehicle which is propelled exclusively by electric power  
4 obtained from overhead trolley wires, though not operated upon rails;

5 (6) No certificates of title need be obtained for any vehicle of a type  
6 subject to registration owned by the federal government;

7 (7) No renewal of the registration of mobile homes shall be required."

8

9 SECTION 2. Arkansas Code § 27-14-1602 is hereby amended to read as  
10 follows:

11 "27-14-1602. Registration - Fee.

12 (a) An owner of a mobile home shall be permitted to register his mobile  
13 home with the office for the purpose of receiving a certificate of title to  
14 the mobile home or for any other purpose. No renewal of the registration  
15 shall be necessary.

16 (b) The registration shall be issued with the payment of no fee and  
17 shall be valid from the date of registration until ownership is transferred."

18

19 SECTION 3. All provisions of this act of general and permanent nature  
20 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code  
21 Revision Commission shall incorporate the same in the Code.

22

23 SECTION 4. If any provisions of this act or the application thereof to  
24 any person or circumstance is held invalid, the invalidity shall not affect  
25 other provisions or applications of the act which can be given effect without  
26 the invalid provisions or application, and to this end the provisions of this  
27 act are declared to be severable.

28

29 SECTION 5. All laws and parts of laws in conflict with this act are  
30 hereby repealed.
