8 "AN ACT TO AMEND §20-82-201 TO ADD A REPRESENTATIVE OF THE
9 OFFICE OF THE ATTORNEY GENERAL TO THE ARKANSAS CHILD
10 ABUSE/RAPE/DOMESTIC VIOLENCE COMMISSION; AND FOR OTHER
11 PURPOSES ."

13 **Subtitle**

14 "TO ADD A REPRESENTATIVE OF THE ATTORNEY GENERAL TO THE
15 CHILD ABUSE/RAPE/DOMESTIC VIOLENCE COMMISSION."

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

18

19 SECTION 1. Arkansas Code 20-82-201 is amended to read as follows:

20 "20-82-201. Creation - Members.

21 (a) There is hereby created the Arkansas Child Abuse/Rape/Domestic
22 Violence Commission to be composed of twenty-four (24) people appointed by the
23 Governor for two-year terms.

24 (b) The membership of the commission shall consist of the following:

25 (1) A representative of domestic violence programs in Arkansas;

26 (2) A representative of the Arkansas State Police;

27 (3) A physician specializing in the treatment of child abuse;

28 (4) A representative of the Arkansas Prosecuting Attorney's
29 Association;

30 (5) The Prosecutor Coordinator;

31 (6) A representative of victim/witness support units;

32 (7) A representative of the Arkansas Law Enforcement Training
33 Academy;

34 (8) A representative of the Arkansas School Counselor's

35 Association;

1 (9) A representative of the Division of Children and Family
2 Services of the Department of Human Services;
3 (10) A representative of Suspected Child Abuse and Neglect
4 (SCAN);
5 (11) A mental health professional, specializing in the treatment
6 of child abuse or domestic violence or rape;
7 (12) A representative of the Arkansas Department of Correction
8 Sex Offender Treatment Program;
9 (13) A member of the Arkansas House of Representatives;
10 (14) A member of the Arkansas Senate;
11 (15) A county sheriff;
12 (16) A city police chief;
13 (17) A municipal judge or circuit judge;
14 (18) A chancery judge;
15 (19) A representative of the State Crime Laboratory;
16 (20) A representative of the Arkansas Department of Health;
17 (21) A representative of rape crisis centers;
18 (22) A representative of the Arkansas Hospital Association;
19 (23) A representative of the Office of the Attorney General; and
20 (24) One (1) member at large.

21 (c) Members of the commission shall be entitled to per diem at the rate
22 of fifty dollars (\$50.00) for each meeting attended and mileage reimbursement
23 in accordance with that provided by state law for state employees."

24

25 SECTION 2. All provisions of this act of a general and permanent nature
26 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
27 Revision Commission shall incorporate the same in the Code.

28

29 SECTION 3. If any provision of this act or the application thereof to
30 any person or circumstance is held invalid, such invalidity shall not affect
31 other provisions or applications of the act which can be given effect without
32 the invalid provision or application, and to this end the provisions of this
33 act are declared to be severable.

35 SECTION 4. All laws and parts of laws in conflict with this act are

1 hereby repealed.
