7 "AN ACT TO AMEND ARKANSAS CODE ANNOTATED §10-3-502 (a) TO
8 ADD THE CHAIRMAN AND VICE-CHAIRMAN OF THE LEGISLATIVE
9 COUNCIL AND THE CHAIRMAN AND VICE-CHAIRMAN OF THE
10 LEGISLATIVE JOINT AUDITING COMMITTEE TO THE JOINT BUDGET
11 COMMITTEE; AND FOR OTHER PURPOSES."

14 "TO ADD THE CHAIRMAN AND VICE-CHAIRMAN OF THE LEGISLATIVE
15 JOINT AUDITING COMMITTEE AND THE LEGISLATIVE COUNCIL TO
16 THE JOINT BUDGET COMMITTEE."

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21

22 SECTION 1. Arkansas Code Annotated §10-3-502 (a) as amended by Act 832
23 of 1991 is amended to read as follows:

24 "(a) The Joint Budget Committee shall consist of forty-four (44)
25 members as follows:

26 (1) twenty (20) members of the House of Representatives;

27 (2) twenty (20) members of the Senate;

28 (3) the Chairman and Vice-Chairman of the Legislative Joint Auditing
29 Committee; and

30 (4) the Chairman and Vice-Chairman of the Legislative Council."

32 SECTION 2. All provisions of this act of a general and permanent
33 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
34 Code Revision Commission shall incorporate the same in the Code.

1 SECTION 3. If any provision of this act or the application thereof to
2 any person or circumstance is held invalid, such invalidity shall not affect
3 other provisions or applications of the act which can be given effect without
4 the invalid provision or application, and to this end the provisions of this
5 act are declared to be severable.

7 SECTION 4. (a) Arkansas Code Annotated §10-3-502 as amended by Act 295
8 of 1991 as found on page 30 of the 1991 Cumulative Supplement to Volume 7 is
9 hereby repealed.

10 (b) All laws and parts of laws in conflict with this act are hereby
11 repealed.

12

13 SECTION 5. EMERGENCY. It is hereby found and determined by the General
14 Assembly that the addition of the Chairman and Vice-Chairman of the
15 Legislation Joint Auditing Committee and the Chairman and Vice-Chairman of the
16 Legislative Council to the Joint Budget Committee is necessary to provide for
17 proper consideration of appropriation bills and budget proposals for
18 consideration by the 1993 General Assembly; and the immediate passage of this
19 act is necessary in order that the Chairman and Vice-Chairman of the
20 Legislative Joint Auditing Committee and the Chairman and Vice-Chairman of the
21 Legislative Council serve on the Joint Budget Committee to assure appropriate
22 representation at the 1993 regular session of the General Assembly.

23 Therefore, an emergency is hereby declared to exist and this act, being
24 necessary for the immediate preservation of the public peace, health, and
25 safety, shall be in full force and effect from and after its passage and
26 approval.
