7 **For An Act To Be Entitled**

8 "AN ACT TO MAKE AN APPROPRIATION FOR THE PURCHASE OF
9 LIBRARY HOLDINGS FOR THE PETIT JEAN TECHNICAL COLLEGE
10 WHICH SHALL BE SUPPLEMENTAL AND IN ADDITION TO THOSE FUNDS
11 APPROPRIATED BY ACT 940 OF 1991, FOR THE REMAINDER OF THE
12 BIENNIAL PERIOD ENDING JUNE 30, 1993; AND FOR OTHER
13 PURPOSES."

Subtitle

16 "AN ACT FOR THE PETIT JEAN TECHNICAL COLLEGE SUPPLEMENTAL
17 APPROPRIATION."

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20

21 SECTION 1. APPROPRIATIONS. There is hereby appropriated, to the Petit
22 Jean Technical College, to be payable from the Petit Jean Technical College
23 Fund, for the purchase of library holdings of the Petit Jean Technical College
24 which shall be supplemental and in addition to those funds appropriated in
25 Section 1 of Act 940 of 1991, for the remainder of the biennial period ending
26 June 30, 1993, the following:

32 SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
33 authorized by this Act shall be limited to the appropriation for such agency
34 and funds made available by law for the support of such appropriations; and
35 the restrictions of the State Purchasing Law, the General Accounting and

1 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
2 Procedures and Restrictions Act, the Higher Education Expenditure Restrictions
3 Act, or their successors, and other fiscal control laws of this State, where
4 applicable, and regulations promulgated by the Department of Finance and
5 Administration, as authorized by law, shall be strictly complied with in
6 disbursement of said funds.

7

8 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General
9 Assembly that any funds disbursed under the authority of the appropriations
10 contained in this Act shall be in compliance with the stated reasons for which
11 this Act was adopted, as evidenced by the Agency Requests, Executive
12 Recommendations and Legislative Recommendations contained in the budget
13 manuals prepared by the Department of Finance and Administration, letters, or
14 summarized oral testimony in the official minutes of the Arkansas Legislative
15 Council or Joint Budget Committee which relate to its passage and adoption.

16

17 SECTION 4. CODE. All provisions of this Act of a general and permanent
18 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
19 Code Revision Commission shall incorporate the same in the Code.

20

21 SECTION 5. SEVERABILITY. If any provision of this Act or the
22 application thereof to any person or circumstance is held invalid, such
23 invalidity shall not affect other provisions or applications of the Act which
24 can be given effect without the invalid provision or application, and to this
25 end the provisions of this Act are declared to be severable.

26

27 SECTION 6. GENERAL REPEALER. All laws and parts of laws in conflict
28 with this Act are hereby repealed.

29

30 SECTION 7. EMERGENCY CLAUSE. It is hereby found and determined by the
31 Seventy-Ninth General Assembly, that funds provided by the Seventy-Eighth
32 General Assembly for the operations of the Petit Jean Technical College are,
33 due to unforeseen circumstances, insufficient for the Petit Jean Technical
34 College to continue to provide essential governmental services; that the
35 provisions of this act will provide the necessary monies for the Petit Jean

1 Technical College to continue such services; and that a delay in the effective
2 date of this Act could work irreparable harm upon the proper administration
3 and provision of essential governmental programs. Therefore, an emergency is
4 hereby declared to exist and this Act being necessary for the immediate
5 preservation of the public peace, health and safety shall be in full force and
6 effect from and after the date of its passage and approval.
