SENATE BILL

For An Act To Be Entitled

8 "AN ACT TO CLARIFY THAT THE COMMISSIONER OF REVENUES IS
9 AUTHORIZED TO ADMINISTER THE TAX, DRIVER'S LICENSE, AND
10 MOTOR VEHICLE LICENSING AND REGISTRATION LAWS; TO ALLOW
11 THE DIRECTOR TO REVISE ADMINISTRATIVE DECISIONS WITHOUT A
12 REQUEST FROM THE TAXPAYER; AND FOR OTHER PURPOSES."

Subtitle

14 "AFFECTS REVENUE COMMISSIONER'S AUTHORITY."

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
18

19 SECTION 1. Ark. Code Ann. §25-8-101(d) is hereby amended to read as
20 follows:

21 "(d) The Director of the Department of Finance and Administration with
22 the advice and consent of the Governor, shall appoint the heads of the
23 respective divisions. The director may appoint an Administrative Assistant
24 for Revenue to serve as the Commissioner of Revenues. All other personnel of
25 the Department of Finance and Administration shall be employed by and serve at
26 the pleasure of the Director of the Department of Finance and Administration,
27 provided that nothing in this section shall be so construed as to reduce any
28 right which an employee of the Department of Finance and Administration shall
29 have under any civil service or merit system."
30

31 SECTION 2. Ark. Code Ann. §25-8-101 is hereby amended by adding a new
32 subsection (f) to read as follows:

33 "(f) For the purposes of the tax, driver's license, and motor vehicle
34 registration and licensing laws the term Director shall mean the Director of
35 the Department of Finance and Administration, the Commissioner of Revenues, or

1 his authorized agent. The Commissioner of Revenues shall act as the
2 Director's agent and take any and all actions necessary to administer the
3 laws."

5 SECTION 3. Ark. Code Ann. §26-18-104(2) is hereby amended by to read as
6 follows:

7 " _Director_ means the Director of the Department of Finance and
8 Administration, State of Arkansas or the Commissioner of Revenues, or his
9 authorized agent;"

10

11 SECTION 4. Ark. Code Ann. §26-18-405(d)(4) is hereby amended by adding
12 a new subsection (C) to read as follows:

13 "(C) The director may within twenty (20) days of the mailing of the
14 decision, revise the decision of the hearing officer regardless of whether the
15 taxpayer has requested a revision. If the director revises the decision of
16 the hearing officer sustaining any portion of an assessment, then a notice of
17 final assessment, as provided by §26-18-401 shall be made upon the final
18 determination of the director. The taxpayer may not request revision of a
19 decision issued by the director under this section."

20

21 SECTION 5. All provisions of this act of a general and permanent nature
22 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
23 Revision Commission shall incorporate the same in the Code.

24

25 SECTION 6. If any provision of this act or the application thereof to
26 any person or circumstance is held invalid, such invalidity shall not affect
27 other provisions or applications of the act which can be given effect without
28 the invalid provision or application, and to this end the provisions of this
29 act are declared to be severable.

31 SECTION 7. All laws and parts of laws in conflict with this act are
32 hereby repealed.
