## 7 **For An Act To Be Entitled**

8 "AN ACT TO AMEND ARKANSAS CODE ANNOTATED §5-13-310 TO  
9 INCLUDE SHOOTING AT OCCUPIABLE STRUCTURES IN THE  
10 DEFINITION OF A TERRORISTIC ACT; AND FOR OTHER PURPOSES."

### 12 **Subtitle**

13 "AN ACT TO INCLUDE SHOOTING AT OCCUPIABLE STRUCTURES IN  
14 THE DEFINITION OF A TERRORISTIC ACT."

15

16 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

17

18 SECTION 1. Arkansas Code §5-13-310 is hereby amended to read as  
19 follows:

20 "5-13-310. Terroristic act.

21 (a) For the purposes of this section, a person commits a terroristic  
22 act when, while not in the commission of a lawful act;

23 (1) He shoots at or in any manner projects an object with the  
24 purpose to cause injury to persons or property at a conveyance which is being  
25 operated or which is occupied by passengers; or

26 (2) He shoots with the purpose to cause injury to persons or  
27 property at an occupiable structure.

28 (b) (1) Any person who shall commit a terroristic act as defined in  
29 subsection (a) of this section shall be deemed guilty of a Class B felony;

30 (2) Any person who shall commit a terroristic act as defined in  
31 subsection (a) shall be deemed guilty of a Class Y felony if the person, with  
32 purpose of causing physical injury to another person, causes serious physical  
33 injury or death to any person.

34 (c) This section shall not repeal any laws or parts of laws in conflict  
35 herewith, but shall be supplemental thereto.

2        SECTION 2. All provisions of this act of a general and permanent nature  
3 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code  
4 Revision Commission shall incorporate the same in the Code.

5

6        SECTION 3. If any provision of this act or the application thereof to  
7 any person or circumstance is held invalid, such invalidity shall not affect  
8 other provisions or applications of the act which can be given effect without  
9 the invalid provision or application, and to this end the provisions of this  
10 act are declared to be severable.

11

12        SECTION 4. All laws and parts of laws in conflict with this act are  
13 hereby repealed.

14

15        SECTION 5. EMERGENCY. It is hereby found and determined by the General  
16 Assembly of the State of Arkansas that the definition of "terroristic act"  
17 does not include shootings into occupiable structures which have become  
18 prevalent in addition to shootings into automobiles which is covered in the  
19 definition. Therefore, an emergency is hereby declared to exist and this act  
20 being necessary for the immediate preservation of the public peace, health,  
21 and safety, shall be in full force and effect from and after its passage and  
22 approval.
