For An Act To Be Entitled

7 "AN ACT TO PRESCRIBE THE MINIMUM AND MAXIMUM SALARIES OF
8 THE CASE COORDINATOR AND THE PROBATION OFFICER OF THE
9 FIFTEENTH JUDICIAL CIRCUIT; AND FOR OTHER PURPOSES."

Subtitle

11 "TO PRESCRIBE THE MINIMUM AND MAXIMUM SALARIES OF THE CASE
12 COORDINATOR AND THE PROBATION OFFICER OF THE FIFTEENTH
13 JUDICIAL CIRCUIT."

15 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

16

17 SECTION 1. (a) The salary of the Case Coordinator of the Fifteen
18 Judicial Circuit Court shall be not less than fifteen thousand dollars
19 (\$15,000) nor more than twenty-three thousand dollars (\$23,000) per year, as
20 determined by order of said Circuit Court.

21 (b) The salary of the Probation Officer of the Fifteenth Judicial
22 Circuit shall be not less than fifteen thousand dollars (\$15,000) nor more
23 than twenty-three thousand dollars (\$23,000) per year, as determined by order
24 of said Circuit Court.

25 (c) Each of said officials shall receive expenses and automobile
26 allowances as authorized for State employees.

27

28 SECTION 2. The provisions of this act are retroactive to January 1,
29 1993.

30

31 SECTION 3. All provisions of this act of a general and permanent nature
32 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
33 Revision Commission shall incorporate the same in the Code.

2 SECTION 4. If any provision of this act or the application thereof to
3 any person or circumstance is held invalid, such invalidity shall not affect
4 other provisions or applications of the act which can be given effect without
5 the invalid provision or application, and to this end the provisions of this
6 act are declared to be severable.

7

8 SECTION 5. All laws and parts of laws in conflict with this act are
9 hereby repealed.

10

11 SECTION 5. EMERGENCY. It is hereby found and determined by the General
12 Assembly of the State of Arkansas that the case load of the Fifteenth Judicial
13 Circuit is increasing significantly and that the current salaries authorized
14 for the Case Coordinator and Probation Officer of the Circuit are inadequate;
15 that this act is designed to authorize increases in the salaries of such
16 officers and should be given effect immediately. Therefore, an emergency is
17 hereby declared to exist and this act being necessary for the immediate
18 preservation of the public peace, health, and safety, shall be in full force
19 and effect from and after its passage and approval.
