7 **For An Act To Be Entitled**

8 "AN ACT TO AMEND VARIOUS SECTIONS OF TITLE 27, CHAPTER 32
9 OF THE ARKANSAS CODE OF 1987, ANNOTATED, TO INCREASE THE
10 MOTOR VEHICLE SAFETY INSPECTION FEE BY ONE DOLLAR (\$1.00)
11 WITH ONE-HALF (1/2) OF THE INCREASE TO GO TO THE
12 INSPECTION STATION AND THE OTHER HALF TO THE ARKANSAS
13 STATE POLICE; AND FOR OTHER PURPOSES."

15 **Subtitle**

16 "TO INCREASE THE MOTOR VEHICLE SAFETY INSPECTION FEE BY
17 ONE DOLLAR (\$1.00)."

18

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20

21 SECTION 1. Subsection (b) of Arkansas Code 27-32-110 is hereby amended
22 to read as follows:

23 "(b) (1) An annual fee set by regulation of the department shall not
24 exceed fifty dollars (\$50.00) and shall accompany the application for a
25 permit.

26 (2) If a permit is not issued, one-half (1/2) of the fee shall be
27 returned to the applicant.

28 (3) The official certificates of inspection and approval shall be
29 obtained from the authority at a cost of two dollars (\$2.00) per certificate.

30 (4) Purchases of the certificates of inspection shall be made
31 through the department, and the department shall remit on a monthly basis to
32 the authority all amounts collected during the preceding month for the
33 purchase of certificates of inspection."

34

35 SECTION 2. Subsection (b) of Arkansas Code 27-32-112 is hereby amended

1 to read as follows:

2 "(b) (1) The fee for the inspection, including the issuance of the
3 certificate of approval, shall be four dollars and fifty cents (\$4.50), with
4 the exception of all motor trucks, trailers, semitrailers, and pole trailers
5 in excess of gross loaded weight of eight thousand pounds (8,000 lbs.).

6 (2) The fee for inspection, including the issuance of the
7 certificate of approval, for all motor trucks, trailers, semitrailers, and
8 pole trailers with a gross loaded weight in excess of eight thousand pounds
9 (8,000 lbs.) shall be under rules and regulations prescribed by the director
10 but shall be not less than four dollars and fifty cents (\$4.50) nor more than
11 eighteen dollars and fifty cents (\$18.50) per inspection."

12

13 SECTION 3. Subsection (b) of Arkansas Code 27-32-116 is hereby amended
14 to read as follows:

15 "(b) One dollar and fifty cents (\$1.50) of the amount collected by the
16 department for the purchase of certificates of inspection under § 27-32-
17 110(b) (3) shall be remitted to the *Arkansas Industrial Development Commission*
18 and the other fifty cents (\$.50) shall be deposited in the State Treasury as
19 special revenues and credited to the State Police Fund. One dollar and fifty
20 cents (\$1.50) of the amount derived from the sale of each certificate of
21 inspection, which is to be *remitted to the Arkansas Industrial Development*
22 *Commission, whether held by the department or the Arkansas Industrial*
23 *Development Commission, shall be cash funds of the Arkansas Industrial*
24 *Development Commission not subject to appropriation, and shall be used and*
25 *applied by the Arkansas Industrial Development Commission only as provided in*
26 *this section and § 22-3-1225.*"

27

28 SECTION 4. All provisions of this act of general and permanent nature
29 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
30 Revision Commission shall incorporate the same in the Code.

31

32 SECTION 5. If any provisions of this act or the application thereof to
33 any person or circumstance is held invalid, the invalidity shall not affect
34 other provisions or applications of the act which can be given effect without
35 the invalid provisions or application, and to this end the provisions of this

1 act are declared to be severable.

2

3 SECTION 6. All laws and parts of laws in conflict with this act are
4 hereby repealed.
