## 7 **For An Act To Be Entitled**

8 "AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES AND  
9 OPERATING EXPENSES FOR THE HEALTH RESOURCES COMMISSION FOR  
10 THE BIENNIAL PERIOD ENDING JUNE 30, 1995; AND FOR OTHER  
11 PURPOSES."

## 13 **Subtitle**

14 "AN ACT FOR THE HEALTH RESOURCES COMMISSION  
15 APPROPRIATION."

16

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

18

19 SECTION 1. REGULAR SALARIES. There is hereby established for the  
20 Health Resources Commission for the 1993-95 biennium, the following maximum  
21 number of regular employees whose salaries shall be governed by the provisions  
22 of the Uniform Classification and Compensation Act (Arkansas Code §§21-5-201  
23 et seq.), or its successor, and all laws amendatory thereto. Provided,  
24 however, that any position to which a specific maximum annual salary is set  
25 out herein in dollars, shall be exempt from the provisions of said Uniform  
26 Classification and Compensation Act. All persons occupying positions  
27 authorized herein are hereby governed by the provisions of the Regular  
28 Salaries Procedures and Restrictions Act (Arkansas Code §21-5-101), or its  
29 successor.

5 SECTION 2. APPROPRIATIONS. There is hereby appropriated, to the Health  
 6 Resources Commission, to be payable from the Health Resources Commission Fund,  
 7 for personal services and operating expenses of the Health Resources  
 8 Commission for the biennial period ending June 30, 1995, the following:

24 SECTION 3. There is established on the books of the State Treasurer,  
 25 State Auditor, and Chief Fiscal Officer of the State a fund to be known as the  
 26 "Health Resources Commission Fund". This fund shall consist of the fund  
 27 balances, on the effective date of this Act and as transferred by the Chief  
 28 Fiscal Officer of the State and the State Treasurer, of the Indigent Health  
 29 Care Investment Trust Fund, or its successor (Ark. Code 19-5-926), and of the  
 30 Indigent Health Care Fund, or its successor (Ark. Code 19-5-1003), and any  
 31 other funds as may be received from gifts, grants, donations, or from public  
 32 or private sources, or as may be provided by the General Assembly, there to be  
 33 used for the support and operations of the Health Resources Commission, as may  
 34 be provided by law.

1           SECTION 4.   Arkansas Code §§ 19-5-926 and 19-5-1003 are hereby  
2 repealed.

3           SECTION 5.   Any balance of appropriation in Section 2 of this Act which  
4 remains on June 30, 1994 shall be carried forward and made available for those  
5 purposes as authorized in Item (04) of Section 2 of this Act for the fiscal  
6 year ending June 30, 1995.

8           SECTION 6.   COMPLIANCE WITH OTHER LAWS.   Disbursement of funds  
9 authorized by this Act shall be limited to the appropriation for such agency  
10 and funds made available by law for the support of such appropriations; and  
11 the restrictions of the State Purchasing Law, the General Accounting and  
12 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
13 Procedures and Restrictions Act, or their successors, and other fiscal control  
14 laws of this State, where applicable, and regulations promulgated by the  
15 Department of Finance and Administration, as authorized by law, shall be  
16 strictly complied with in disbursement of said funds.

17

18           SECTION 7.   LEGISLATIVE INTENT.   It is the intent of the General  
19 Assembly that any funds disbursed under the authority of the appropriations  
20 contained in this Act shall be in compliance with the stated reasons for which  
21 this Act was adopted, as evidenced by the Agency Requests, Executive  
22 Recommendations and Legislative Recommendations contained in the budget  
23 manuals prepared by the Department of Finance and Administration, letters, or  
24 summarized oral testimony in the official minutes of the Arkansas Legislative  
25 Council or Joint Budget Committee which relate to its passage and adoption.

27           SECTION 8.   CODE.   All provisions of this Act of a general and permanent  
28 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas  
29 Code Revision Commission shall incorporate the same in the Code.

30

31           SECTION 9.   SEVERABILITY.   If any provision of this Act or the  
32 application thereof to any person or circumstance is held invalid, such  
33 invalidity shall not affect other provisions or applications of the Act which  
34 can be given effect without the invalid provision or application, and to this  
35 end the provisions of this Act are declared to be severable.

2        SECTION 10. GENERAL REPEALER. All laws and parts of laws in conflict  
3 with this Act are hereby repealed.

4

5        SECTION 11. EMERGENCY CLAUSE. It is hereby found and determined by the  
6 Seventy-Ninth General Assembly, that the Constitution of the State of Arkansas  
7 prohibits the appropriation of funds for more than a two (2) year period; that  
8 the effectiveness of this Act on July 1, 1993 is essential to the operation of  
9 the agency for which the appropriations in this Act are provided, and that in  
10 the event of an extension of the Regular Session, the delay in the effective  
11 date of this Act beyond July 1, 1993 could work irreparable harm upon the  
12 proper administration and provision of essential governmental programs.  
13 Therefore, an emergency is hereby declared to exist and this Act being  
14 necessary for the immediate preservation of the public peace, health and  
15 safety shall be in full force and effect from and after its passage and  
16 approval.
