# A Bill

**SENATE BILL**

## For An Act To Be Entitled

8 "AN ACT TO AMEND ARKANSAS CODE SECTION 27-14-601  
9 (a) (3) (I) (i) (a) FOR THE PURPOSES OF PROVIDING THE ANNUAL  
10 REGISTRATION FEE; AND FOR OTHER PURPOSES."

## Subtitle

13 "TO PROVIDE REGISTRATION FEES FOR BOAT TRAILERS AND TRAVEL  
14 TRAILERS DRAWN BY A ONE TON OR LESS TRUCK."

16 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

18 SECTION 1. Arkansas Code 27-14-601 (a) (3) (I) (i) (a) is amended to read  
19 as follows:

20 "(I) Class Nine \_\_\_\_ (i) (a) For the purpose of evidencing registration  
21 of trailers, semitrailers, and full trailers, there shall be issued special  
22 license plates and annual registration fees charged and collected according to  
23 the following schedule:

24 (1) All trailers drawn by automobiles and Class One trucks, and all  
25 boat trailers and travel trailers drawn by any truck, which truck has a load  
26 capacity of one (1) ton or less, a fee of seven dollars (\$7.00);

27 (2) All semitrailers used in combination with Classes Two through Eight  
28 trucks, with the exception of those for which a fee is set out in (i) (a) (1),  
29 above, a fee of twenty dollars (\$20.00). Provided, however, the owner of any  
30 semitrailer used in combination with Classes Two through Eight trucks may, at  
31 his option, pay a fee of sixty-five dollars (\$65.00) for issuance of a  
32 permanent registration that shall remain valid, without annual renewal, until  
33 he sells or otherwise disposes of the semitrailer for which such registration  
34 is issued. Permanent registrations issued under this subdivision shall not be  
35 transferred to other owners or other vehicles, and shall not be replaced under

2 (3) Full trailers operated in the transportation of farm products and  
3 other natural resources described as Class Eight, a fee of eight dollars  
4 (\$8.00); and

5 (4) For all other full trailers there shall be charged an annual  
6 license fee computed on the gross loaded weight of the vehicle at the  
7 appropriate rate provided by Classes Two through Seven of subsection (a)(3) of  
8 this section."

9

10 SECTION 2. All provisions of this act of a general and permanent  
11 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas  
12 Code Revision Commission shall incorporate the same in the Code.

13

14 SECTION 3. If any provision of this act or the application thereof to  
15 any person or circumstance is held invalid, such invalidity shall not affect  
16 other provisions or applications of the act which can be given effect without  
17 the invalid provision or application, and to this end the provisions of this  
18 act are declared to be severable.

20 SECTION 4. All laws and parts of laws in conflict with this act are  
21 hereby repealed.
