For An Act To Be Entitled

7 "AN ACT TO AMEND ARKANSAS CODE ANNOTATED § 6-13-1006 TO
8 PROVIDE THAT THE BOARD OF DIRECTORS OF EACH EDUCATION
9 SERVICE COOPERATIVE SHALL INCLUDE AT LEAST ONE (1) TEACHER
10 AND ONE (1) PARENT MEMBER; TO AMEND TITLE 6, CHAPTER 13,
11 SUBCHAPTER 10 OF THE ARKANSAS CODE ANNOTATED BY ADDING TWO
12 (2) NEW SECTIONS TO PROVIDE FOR THE SELECTION OF AT LEAST
13 ONE (1) TEACHER AND ONE (1) PARENT TO SERVE ON EACH
14 EDUCATION SERVICE COOPERATIVE BOARD; AND FOR OTHER
15 PURPOSES."

Subtitle

17 "TO PROVIDE THAT THE BOARD OF DIRECTORS OF EACH EDUCATION
18 SERVICE COOPERATIVE SHALL INCLUDE AT LEAST ONE TEACHER AND
19 ONE PARENT MEMBER."

21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22

23 SECTION 1. Arkansas Code § 6-13-1006(a) is hereby amended to read as
24 follows:

25 "(a) Each education service cooperative shall be governed by a board of
26 directors consisting of one (1) representative of each school district board
27 of directors within the boundary of the cooperative and at least one (1)
28 teacher and one (1) parent member selected according to the procedures in § 6-
29 13-1023."

30

31 SECTION 2. Title 6, Chapter 13, Subchapter 10 of the Arkansas Code is
32 hereby amended by adding the following new sections to read as follows:

33 "6-13-1023. (a) In September of each odd-numbered year, the personnel

1 policy committee in each school district that is a member of an education
2 service cooperative shall nominate one (1) teacher from the district to be
3 considered for a position on the board of directors of the cooperative. If
4 there is no personnel policy committee, the majority teacher association
5 recognized by the school district shall nominate the teacher. In October of
6 each odd-numbered year, the board of directors of each cooperative shall
7 select by lot one (1) of the nominated teachers to serve on the board for a
8 two-year term.

9 (b) In September of each odd-numbered year, the parent-teacher
10 organization in the school district that is a member of an education service
11 cooperative shall nominate one (1) parent from the district to be considered
12 for a position on the board of directors of the cooperative. If there is no
13 parent-teacher organization in the school district, the board of directors of
14 the school district shall nominate one (1) parent. In October of each odd-
15 numbered year, the board of directors of the cooperative shall select by lot
16 one (1) of the nominated parents to serve on the board for a two-year term.

18 6-13-1024. As used in this subchapter, unless the context otherwise
19 requires:

20 (1) Teacher means a classroom teacher, librarian, or guidance
21 counselor employed by a school district that is a member of an education
22 service cooperative.

23 (2) Parent means any parent or guardian of a child enrolled in a
24 school district that is a member of an education service cooperative."

25
26 SECTION 3. All provisions of this act of a general and permanent nature
27 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
28 Revision Commission shall incorporate the same in the Code.
29

30 SECTION 4. If any provision of this act or the application thereof to
31 any person or circumstance is held invalid, such invalidity shall not affect
32 other provisions or applications of the act which can be given effect without
33 the invalid provision or application, and to this end the provisions of this
34 act are declared to be severable.
