SENATE BILL

For An Act To Be Entitled

8 "AN ACT TO MAKE AN APPROPRIATION FOR THE PURCHASE OF A GAS
9 CHROMATOGRAPH FOR THE ARKANSAS BUREAU OF STANDARDS WHICH
10 SHALL BE SUPPLEMENTAL AND IN ADDITION TO THOSE FUNDS
11 APPROPRIATED BY ACT 206 OF 1991, FOR THE REMAINDER OF THE
12 BIENNIAL PERIOD ENDING JUNE 30, 1993; AND FOR OTHER
13 PURPOSES."

Subtitle

16 "AN ACT FOR THE ARKANSAS BUREAU OF STANDARDS SUPPLEMENTAL
17 APPROPRIATION."

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. APPROPRIATIONS. There is hereby appropriated, to the
22 Arkansas Bureau of Standards, to be payable from the State General Services
23 Fund Account, for the purchase of a gas chromatograph of the Arkansas Bureau
24 of Standards which shall be supplemental and in addition to those funds
25 appropriated in Section 2 of Act 206 of 1991, for the remainder of the
26 biennial period ending June 30, 1993, the following:

1 invalidity shall not affect other provisions or applications of the Act which
2 can be given effect without the invalid provision or application, and to this
3 end the provisions of this Act are declared to be severable.

5 SECTION 7. GENERAL REPEALER. All laws and parts of laws in conflict
6 with this Act are hereby repealed.

7

8 SECTION 8. EMERGENCY CLAUSE. It is hereby found and determined by the
9 Seventy-Ninth General Assembly meeting in Regular Session, that funds provided
10 by the Seventy-Eighth General Assembly for the operations of the Arkansas
11 Bureau of Standards are, due to unforeseen circumstances, insufficient for the
12 Arkansas Bureau of Standards to continue to provide essential governmental
13 services; that the provisions of this act will provide the necessary monies
14 for the Arkansas Bureau of Standards to continue such services; and that a
15 delay in the effective date of this Act could work irreparable harm upon the
16 proper administration and provision of essential governmental programs.
17 Therefore, an emergency is hereby declared to exist and this Act being
18 necessary for the immediate preservation of the public peace, health and
19 safety shall be in full force and effect from and after the date of its
20 passage and approval.
