7 **For An Act To Be Entitled**

8 "AN ACT TO REQUIRE COUNTY CLERKS WHICH HAVE VOTER
9 REGISTRATION LISTS ON COMPUTER TO PROVIDE AT REASONABLE
10 COST A COPY OF THE VOTER REGISTRATION LIST ON COMPUTER
11 DISK OR TAPE TO CANDIDATES FOR ELECTIVE OFFICE AND HOLDERS
12 OF ELECTIVE OFFICE; AND FOR OTHER PURPOSES."

14 **Subtitle**

15 "COMPUTER VOTER REGISTRATION LISTS TO BE PROVIDED TO
16 CANDIDATES FOR ELECTIVE OFFICE AND HOLDERS OF ELECTIVE
17 OFFICE."

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. Every county clerk who maintains on computer the list of
22 registered voters within the county shall, on request and at reasonable cost,
23 provide the list on computer disk or tape to candidates for elective office
24 and holders of elective office. The list shall include at least the name,
25 address, and precinct number of the voters. The clerk may require the
26 candidate or office holder to furnish the computer disk or tape or may require
27 the candidate or office holder to reimburse the county for the cost of the
28 computer disk or tape and may levy a reasonable charge for the list, not to
29 exceed the charge for a written copy of the list. As a condition to providing
30 the voter registration list on computer disk or tape, the county clerk may
31 require the candidate or office holder to agree to use the list only for
32 campaign or office holding purposes and not for resale.

34 SECTION 2. All provisions of this act of a general and permanent nature
35 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code

1 Revision Commission shall incorporate the same in the Code.

2

3 SECTION 3. If any provision of this act or the application thereof to
4 any person or circumstance is held invalid, such invalidity shall not affect
5 other provisions or applications of the act which can be given effect without
6 the invalid provision or application, and to this end the provisions of this
7 act are declared to be severable.

8

9 SECTION 4. All laws and parts of laws in conflict with this act are
10 hereby repealed.
