7 **For An Act To Be Entitled**

8 "AN ACT TO AMEND TITLE 22, CHAPTER 8, SUBCHAPTER 2 OF THE
9 ARKANSAS CODE OF 1987, TO AUTHORIZE THE ARKANSAS
10 DEPARTMENT OF STATE POLICE TO UTILIZE MONIES DEPOSITED
11 INTO THE MOTOR VEHICLE ACQUISITION REVOLVING FUND FOR THE
12 RENOVATION OF STATE POLICE MOTOR VEHICLES; AND FOR OTHER
13 PURPOSES."

15 **Subtitle**

16 "AN ACT TO AUTHORIZE THE STATE POLICE TO UTILIZE MONIES IN
17 THE MOTOR VEHICLE ACQUISITION REVOLVING FUND FOR
18 RENOVATING MOTOR VEHICLES."

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21

22 SECTION 1. Arkansas Code Title 22, Chapter 8, Subchapter 2 is amended
23 to add the following new section:

24 "22-8-210. Motor Vehicle Renovation.

25 Funds deposited into the Motor Vehicle Acquisition Revolving Fund
26 created by Arkansas Code §19-5-1002 (a) and Arkansas Code §22-8-206 (b), which
27 may be made available for the purchase of motor vehicles for the Department of
28 Arkansas State Police, may in addition be made available and used for expenses
29 associated with the renovation of State Police motor vehicles. If the Director
30 of the Department of Arkansas State Police determines the cost associated with
31 renovating or repairing State Police motor vehicles is economically beneficial,
32 he shall contract with a qualified vendor and, when invoiced, shall submit
33 said invoice to the Chief Fiscal Officer of the State who shall direct payment
34 from monies set aside in the Motor Vehicle Acquisition Revolving Fund for the
35 Department of Arkansas State Police."

2 SECTION 2. All provisions of this Act of a general and permanent nature
3 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
4 Revision Commission shall incorporate the same in the Code.

6 SECTION 3. If any provision of this Act or the application thereof to
7 any person or circumstance is held invalid, such invalidity shall not affect
8 other provisions or applications of this Act which can be given effect without
9 the invalid provision or application, and to this end the provisions of this
10 Act are declared to be severable.

11

12 SECTION 4. All laws and parts of laws in conflict with this Act are
13 hereby repealed.

14

15 SECTION 5. EMERGENCY CLAUSE. It is hereby found and determined by the
16 Seventy-Ninth General Assembly, that authorizing the payment of costs
17 associated with the renovation of State Police motor vehicles from the Motor
18 Vehicle Acquisition Revolving Fund is economically beneficial to the State of
19 Arkansas, and the savings realized from such renovations will allow the
20 Arkansas Department of State Police to replace high mileage and possibly
21 dangerous motor vehicles sooner. Therefore, an emergency is hereby declared to
22 exist and this Act being necessary for the immediate preservation of the
23 public peace, health and safety shall be in full force and effect from its
24 passage and approval.
