8 HONORING THE LATE JULIAN JAMES OF CRAIGHEAD COUNTY WHO, IN
9 1941, PASSED HOUSE CONCURRENT RESOLUTION NO. 19, DURING
10 THE FIFTY-THIRD GENERAL ASSEMBLY, ESTABLISHING THE
11 ARKANSAS TRAVELER TITLE TO HONOR DISTINGUISHED VISITORS,
12 CITIZENS, AND FORMER CITIZENS OF THE STATE WHO HAVE
13 DISTINGUISHED THEMSELVES IN BUSINESS, POLITICS AND THE
14 PROFESSIONS.

17 HONORING THE LATE JULIAN JAMES OF CRAIGHEAD COUNTY.

19 WHEREAS, the distinguished Julian James of Craighead County served with
20 great distinction in the Arkansas House of Representatives in 1939 and 1941
21 and in the Arkansas State Senate in 1943 and 1945; and

22 WHEREAS, the Honorable Franklin Delano Roosevelt, President of the
23 United States, did us, the people of Arkansas, on June 10, 1936, the very
24 great honor to lend his presence and prestige to the occasion of our
25 celebration of the State's birthday, that day, June 15, 1936, being the one
26 hundredth anniversary of the admission of Arkansas into the Union of free and
27 sovereign states; and

28 WHEREAS, then Representative Julian James, after President Franklin
29 Delano Roosevelt's visit to Arkansas, recognized the need to recognize such
30 great men for their efforts on behalf of our people; and

31 WHEREAS, Representative Julian James introduced and successfully passed
32 House Concurrent Resolution No. 19 in 1941 providing that the Governor of
33 Arkansas be authorized to designate and appoint distinguished visitors,
34 citizens, and former citizens who have distinguished themselves in various
35 fields of endeavor as an ARKANSAS TRAVELER,

2 NOW THEREFORE,

3 BE IT RESOLVED BY THE SENATE OF THE SEVENTY-NINTH GENERAL ASSEMBLY OF THE
4 STATE OF ARKANSAS, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN:

6 That the people of the State of Arkansas be made aware of the untiring
7 efforts of Julian James in serving Craighead County and calling attention to
8 such legislation which he promoted during his service in the Arkansas
9 Legislature.

11 BE IT FURTHER RESOLVED THAT the Secretary of the Senate send a copy of
12 this Resolution to his widow; Evelyn James Skeen and son, Julian James, Jr.,
13 both of Jonesboro, Arkansas, and daughter, Renee James Jackson of Fairfield
14 Bay, Arkansas.
