7 **For An Act To Be Entitled**

8 "AN ACT TO MAKE AN APPROPRIATION FOR DATA PROCESSING
9 SERVICES AND COMPUTER SYSTEM UPGRADE FOR THE ARKANSAS
10 CRIME INFORMATION CENTER WHICH SHALL BE SUPPLEMENTAL AND
11 IN ADDITION TO THOSE FUNDS APPROPRIATED IN SECTION 3 OF
12 ACT 58 OF 1993, FOR THE REMAINDER OF THE FISCAL YEAR
13 ENDING JUNE 30, 1995; AND FOR OTHER PURPOSES."

15 **Subtitle**

16 "AN ACT FOR THE ARKANSAS CRIME
17 INFORMATION CENTER SUPPLEMENTAL
18 APPROPRIATION."

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21

22 SECTION 1. APPROPRIATIONS. There is hereby appropriated, to the
23 Arkansas Crime Information Center, to be payable from the Crime Information
24 System Fund, for data processing services of the Arkansas Crime Information
25 Center which shall be supplemental and in addition to those funds appropriated
26 in Section 3 of Act 58 of 1993, for the remainder of the fiscal year ending
27 June 30, 1995, the following:

5 SECTION 2. FUNDING TRANSFER. Immediately upon the effective date of
 6 this Act, the Chief Fiscal Office of the State shall transfer on his books and
 7 those of the State Treasurer the sum of eighty four thousand dollars (\$84,000)
 8 from the General Revenue Allotment Reserve Fund to the Crime Information
 9 System Fund to provide funds for the appropriation provided in Section 1
 10 herein.

11

12 SECTION 3. APPROPRIATIONS. There is hereby appropriated, to the
 13 Arkansas Crime Information Center, to be payable from the Crime Information
 14 Center Fund, for computer system upgrade of the Arkansas Crime Information
 15 Center, for the remainder of the fiscal year ending June 30, 1995, the
 16 following:

22 SECTION 4. FUNDING TRANSFER. The Arkansas Crime Information Center
 23 shall from time to time as needed, certify to the Chief Fiscal Officer of the
 24 State, the amount of funds needed for the computer system upgrade of the
 25 Arkansas Crime Information Center. Upon the receipt of such certification,
 26 the State Treasurer shall transfer up to, but not to exceed in total for
 27 fiscal year 1994-95 the sum of four hundred ten thousand dollars (\$410,000)
 28 from the General Revenue Allotment Reserve Fund to the Crime Information
 29 Center Fund to provide funds for the appropriation provided in Section 3
 30 herein.

32 SECTION 5. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
 33 authorized by this Act shall be limited to the appropriation for such agency
 34 and funds made available by law for the support of such appropriations; and
 35 the restrictions of the State Purchasing Law, the General Accounting and

1 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
2 Procedures and Restrictions Act, or their successors, and other fiscal control
3 laws of this State, where applicable, and regulations promulgated by the
4 Department of Finance and Administration, as authorized by law, shall be
5 strictly complied with in disbursement of said funds.

7 SECTION 6. LEGISLATIVE INTENT. It is the intent of the General
8 Assembly that any funds disbursed under the authority of the appropriations
9 contained in this Act shall be in compliance with the stated reasons for which
10 this Act was adopted, as evidenced by the Agency Requests, Executive
11 Recommendations and Legislative Recommendations contained in the budget
12 manuals prepared by the Department of Finance and Administration, letters, or
13 summarized oral testimony in the official minutes of the Arkansas Legislative
14 Council or Joint Budget Committee which relate to its passage and adoption.

16 SECTION 7. CODE. All provisions of this Act of a general and permanent
17 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
18 Code Revision Commission shall incorporate the same in the Code.

19

20 SECTION 8. SEVERABILITY. If any provision of this Act or the
21 application thereof to any person or circumstance is held invalid, such
22 invalidity shall not affect other provisions or applications of the Act which
23 can be given effect without the invalid provision or application, and to this
24 end the provisions of this Act are declared to be severable.

25

26 SECTION 9. GENERAL REPEALER. All laws and parts of laws in conflict
27 with this Act are hereby repealed.

28

29 SECTION 10. EMERGENCY CLAUSE. It is hereby found and determined by the
30 Seventy-Ninth General Assembly, meeting in Second Extraordinary Session, that
31 the provisions of this Act will provide the necessary monies for the Arkansas
32 Crime Information Center to continue essential crime information services; and
33 that a delay in the effective date of this Act could cause irreparable harm
34 upon the proper administration and provision of essential governmental
35 programs. Therefore, an emergency is hereby declared to exist and this Act
