# A Bill

**SENATE BILL**

## For An Act To Be Entitled

8 "TO PROVIDE THAT ALL LAWS PASSED DURING THIS EXTRAORDINARY  
9 SESSION SHALL BE APPLIED EQUALLY AND FAIRLY TO ALL PERSONS  
10 WHO ARE SUBJECT THERETO; AND FOR OTHER PURPOSES."

## Subtitle

13 "TO PROVIDE THAT ALL LAWS PASSED DURING  
14 THIS EXTRAORDINARY SESSION SHALL BE  
15 APPLIED EQUALLY AND FAIRLY TO ALL  
16 PERSONS WHO ARE SUBJECT THERETO."

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

19  
20 SECTION 1. It is the purpose and intent of this act to express to all  
21 law enforcement personnel, judges, prosecuting attorneys, and other persons  
22 who will enforce the laws passed by this Extraordinary Session that the  
23 General Assembly intends and expects all of the laws passed during this  
24 Extraordinary Session to be applied equally and fairly to all persons who are  
25 subject to those laws.

26  
27 SECTION 2. All provisions of this act of a general and permanent nature  
28 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code  
29 Revision Commission shall incorporate the same in the Code.

30  
31 SECTION 3. If any provision of this act or the application thereof to  
32 any person or circumstance is held invalid, such invalidity shall not affect  
33 other provisions or applications of the act which can be given effect without  
34 the invalid provision or application, and to this end the provisions of this  
35 act are declared to be severable.

SECTION 4. All laws and parts of laws in conflict with this act are hereby repealed.

SECTION 5. EMERGENCY. It is hereby found and determined by the General Assembly that this act expresses the intent of the General Assembly that all the laws passed during this Extraordinary Session be applied equally and fairly to all persons who are subject to those laws, and that this act should go into effect immediately in order to provide the notice of that intent to all law enforcement personnel, court personnel, and other personnel who will enforce the acts. Therefore, an emergency is hereby declared to exist, and this act being immediately necessary for the preservation of the public peace, health, and safety shall be in full force and effect from and after its passage and approval.
