7 "AN ACT TO AMEND ARK. CODE ANN. § 17-50-103 TO AUTHORIZE
8 INDIVIDUALS LICENSED OR REGISTERED TO PERFORM HVACR WORK
9 MAY PERFORM ELECTRICAL CONNECTIONS TO HEATING AND AIR
10 CONDITIONING UNITS WITHOUT OBTAINING ANY OTHER LICENSE TO
11 PERFORM THE CONNECTIONS; AND FOR OTHER PURPOSES."

14 "TO AUTHORIZE HVACR LICENSEES TO PERFORM
15 ELECTRICAL CONNECTIONS TO HEATING AND
16 AIR CONDITIONING UNITS WITHOUT OBTAINING
17 OTHER LICENSES TO PERFORM THE
18 CONNECTIONS."

21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22

23 SECTION 1. Arkansas Code Annotated § 17-50-103 is hereby amended to
24 read as follows:

25 "17-50-103. HVACR gas fitting and electrical work.

26 (a) Any individual licensed or registered to perform HVACR work may
27 perform HVACR gas fitting work without obtaining any other license to perform
28 the work. HVACR gas fitting work shall be performed in accordance with the
29 appropriate standards for gas fitting work.

30 (b) Any individual licensed or registered to perform HVACR work may
31 perform electrical connections to heating and air conditioning units without
32 obtaining any other license to perform the work, so long as *the connection is*
33 *made to a disconnecting means suitable in capacity for the equipment to be*
34 *served and is provided by others within ten (10) feet of the unit.* Nothing
35 in this chapter shall be construed as allowing an HVACR licensee to perform

1 electrical work without complying with any applicable local code, city code,
2 state code, or national code pertaining to electrical work."

3

4 SECTION 2. All provisions of this act of a general and permanent
5 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
6 Code Revision Commission shall incorporate the same in the Code.

7

8 SECTION 3. If any provision of this act or the application thereof to
9 any person or circumstance is held invalid, such invalidity shall not affect
10 other provisions or applications of the act which can be given effect without
11 the invalid provision or application, and to this end the provisions of this
12 act are declared to be severable.

13

14 SECTION 4. All laws and parts of laws in conflict with this act are
15 hereby repealed.
