8 "AN ACT TO CLARIFY ARKANSAS CODE 14-42-206 BY PROVIDING
9 THAT EVERY PERSON SIGNING A PETITION FOR NOMINATION OF AN
10 INDEPENDENT CANDIDATE FOR MUNICIPAL OFFICE SHALL INDICATE
11 HIS/HER STREET ADDRESS; AND FOR OTHER PURPOSES."

13 Subtitle

14 "PROVIDING THAT EVERY PERSON SIGNING A
15 PETITION FOR NOMINATION OF AN
16 INDEPENDENT CANDIDATE FOR MUNICIPAL
17 OFFICE SHALL INDICATE HIS/HER STREET
18 ADDRESS."

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22 SECTION 1. Arkansas Code 14-42-206 (b) (1) is amended to read as
23 follows:

24 "(b) (1) Any person desiring to become an independent candidate for
25 municipal office in cities and towns with the mayor-council form of
26 government shall, not more than eighty (80) days nor less than sixty (60)
27 days prior to the general election, file with the county board of election
28 commissioners their petition of nomination in substantially the following
29 forms:

30 (for all candidates except aldermen in cities of the first and second
31 class)

19 SECTION 2. All provisions of this act of a general and permanent
20 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
21 Code Revision Commission shall incorporate the same in the Code.

22

23 SECTION 3. If any provision of this act or the application thereof to
24 any person or circumstance is held invalid, such invalidity shall not affect
25 other provisions or applications of the act which can be given effect without
26 the invalid provision or application, and to this end the provisions of this
27 act are declared to be severable.

28

29 SECTION 4. All laws and parts of laws in conflict with this act are
30 hereby repealed.
