For An Act To Be Entitled

8 "AN ACT TO AMEND ARKANSAS CODE 3-3-210 TO PROHIBIT THE
9 SALE OF INTOXICATING LIQUOR FOR OFF PREMISES CONSUMPTION
10 BEFORE SEVEN O_CLOCK (7:00) A.M. AND AFTER TEN O_CLOCK
11 (10:00) P.M. ON WEEKDAYS AND SATURDAYS OR AT ANY TIME ON
12 SUNDAYS; AND FOR OTHER PURPOSES."

15 "PROHIBIT SALE OF INTOXICATING LIQUOR
16 FOR OFF PREMISES CONSUMPTION BEFORE
17 SEVEN O_CLOCK (7:00) A.M. AND AFTER TEN
18 O_CLOCK (10:00) P.M. ON WEEKDAYS AND
19 SATURDAYS OR AT ANY TIME ON SUNDAYS."

21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23 SECTION 1. Arkansas Code 3-3-210 is amended to read as follows:

24 "§ 3-3-210. Sale on Sunday or early weekday mornings.

25 Any person who shall sell intoxicating alcoholic liquor for on premises
26 consumption on Sunday, except as such sales are authorized by §§ 3-9-215 and
27 3-9-401 et seq., or between 1:00 a.m. and 7:00 a.m. on week days and any
28 person who shall sell intoxicating alcoholic liquor for off premises
29 consumption between the hours of ten (10:00) p.m. and seven (7:00) a.m. on
30 weekdays and Saturdays or at any time on Sundays shall be guilty of a
31 misdemeanor and for the first offense be punishable by a fine of not less
32 than one hundred dollars (\$100) nor more than two hundred fifty dollars
33 (\$250), and for the second and subsequent offenses he shall be guilty of a
34 misdemeanor and punishable by a fine of not less than two hundred fifty
35 dollars (\$250) nor more than five hundred dollars (\$500) or by imprisonment

1 in the county jail for not less than ten (10) days nor more than six (6)
2 months, or both so fined and imprisoned in the discretion of the court or
3 jury."

5 SECTION 2. All provisions of this act of a general and permanent
6 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
7 Code Revision Commission shall incorporate the same in the Code.

8

9 SECTION 3. If any provision of this act or the application thereof to
10 any person or circumstance is held invalid, such invalidity shall not affect
11 other provisions or applications of the act which can be given effect without
12 the invalid provision or application, and to this end the provisions of this
13 act are declared to be severable.

14

15 SECTION 4. All laws and parts of laws in conflict with this act are
16 hereby repealed.
