For An Act To Be Entitled

7 "AN ACT TO MAKE AN APPROPRIATION TO ALLEViate CONDITIONS
8 ARISING IN PUBLIC EMERGENCIES FOR THE OFFICE OF THE
9 GOVERNOR WHICH SHALL BE SUPPLEMENTAL AND IN ADDITION TO
10 THOSE FUNDS APPROPRIATED BY ACT 601 OF 1993, FOR THE
11 REMAINDER OF THE BIENNIAL PERIOD ENDING JUNE 30, 1995; AND
12 FOR OTHER PURPOSES."

Subtitle

14 "AN ACT TO MAKE A SUPPLEMENTAL APPROPRIATION FOR THE
15 OFFICE OF THE GOVERNOR."

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

18

19 SECTION 1. APPROPRIATIONS . There is hereby appropriated, to the
20 Office of the Governor, to be payable from the Miscellaneous Revolving Fund,
21 for the purposes provided for by Arkansas Code 19-2-404 which shall be
22 supplemental and in addition to those funds appropriated in Section 1 of Act
23 601 of 1993, for the remainder of the biennial period ending June 30,
24 1995, the following:

27 SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
28 authorized by this Act shall be limited to the appropriation for such agency
29 and funds made available by law for the support of such appropriations; and
30 the restrictions of the State Purchasing Law, the General Accounting and

1 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
2 Procedures and Restrictions Act, or their successors, and other fiscal
3 control laws of this State, where applicable, and regulations promulgated by
4 the Department of Finance and Administration, as authorized by law, shall be
5 strictly complied with in disbursement of said funds.

7 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General
8 Assembly that any funds disbursed under the authority of the appropriations
9 contained in this Act shall be in compliance with the stated reasons for
10 which this Act was adopted, as evidenced by the Agency Requests, Executive
11 Recommendations and Legislative Recommendations contained in the budget
12 manuals prepared by the Department of Finance and Administration, letters, or
13 summarized oral testimony in the official minutes of the Arkansas Legislative
14 Council or Joint Budget Committee which relate to its passage and adoption.

15

16 SECTION 4. CODE. All provisions of this Act of a general and
17 permanent nature are amendatory to the Arkansas Code of 1987 Annotated and
18 the Arkansas Code Revision Commission shall incorporate the same in the Code.

19

20 SECTION 5. SEVERABILITY. If any provision of this Act or the
21 application thereof to any person or circumstance is held invalid, such
22 invalidity shall not affect other provisions or applications of the Act which
23 can be given effect without the invalid provision or application, and to this
24 end the provisions of this Act are declared to be severable.

25

26 SECTION 6. GENERAL REPEALER. All laws and parts of laws in conflict
27 with this Act are hereby repealed.

28

29 SECTION 7. EMERGENCY CLAUSE. It is hereby found and determined by the
30 Eightieth General Assembly meeting in Regular Session, that funds provided by
31 the Seventy-Ninth General Assembly for the operations of the Office of the
32 Governor are, due to unforeseen circumstances, insufficient for the Office of
33 the Governor to continue to provide the necessary monies for the Office of
34 the Governor to continue such services; and that a delay in the effective
35 date of this Act could work irreparable harm upon the proper administration

1 and provision of essential governmental programs. Therefore, an emergency is
2 hereby declared to exist and this Act being necessary for the immediate
3 preservation of the public peace, health and safety shall be in full force
4 and effect from and after the date of its passage and approval.
