7 "AN ACT TO AMEND ARKANSAS CODE 10-3-701 TO PROVIDE THAT
8 THE HOUSE MEMBERSHIP AND THE HOUSE CHAIRMAN AND VICE
9 CHAIRMAN OF THE JOINT COMMITTEE ON PUBLIC RETIREMENT AND
10 SOCIAL SECURITY PROGRAMS SHALL BE SELECTED IN ACCORDANCE
11 WITH HOUSE RULES; AND FOR OTHER PURPOSES."

14 "TO AMEND ARKANSAS CODE 10-3-701."

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

18

19 SECTION 1. Arkansas Code 10-3-701 is amended to read as follows:

20 "10-3-701. Creation - Members.

21 (a) There is established a joint committee of the House of
22 Representatives and the Senate to be known as the Joint Committee on Public
23 Retirement and Social Security Programs, to consist of seventeen (17)
24 members.

25 (b) The ten (10) House members shall be selected as prescribed by
26 House Rule. The Committee on Committees of the Senate shall name, at the
27 commencement of each regular session of the General Assembly, seven (7)
28 members of the Senate to serve on the joint committee.

29 (c) The Senate Committee on Committees shall designate one (1) Senate
30 member of the committee to serve as Senate co-chairman of the committee and
31 one (1) Senate member to serve as Senate co-vice chairman of the committee.
32 The House membership of the committee, the House co-chairman of the
33 committee, and the House co-vice chairman of the committee shall be selected
34 as provided by House Rules."

1 SECTION 2. All provisions of this act of a general and permanent
2 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
3 Code Revision Commission shall incorporate the same in the Code.

4

5 SECTION 3. If any provision of this act or the application thereof to
6 any person or circumstance is held invalid, such invalidity shall not affect
7 other provisions or applications of the act which can be given effect without
8 the invalid provision or application, and to this end the provisions of this
9 act are declared to be severable.

10

11 SECTION 4. All laws and parts of laws in conflict with this act are
12 hereby repealed.
