         SECTION 1. Arkansas Code 7-1-103 is amended to read as follows:
         "7-1-103. Miscellaneous misdemeanor offenses - Penalties.

         The violation of any of the following shall be deemed misdemeanors

   punishable as provided in this section:
         (1) It shall be unlawful for any person to appoint or offer to appoint

26 anyone to any office or position of trust, or for any person to influence,
   attempt to influence, or offer to influence the appointment, nomination, or
   election of any person to office, in consideration of the support or
  assistance of the person for any candidate in any election in this state;

         (2)(A) It shall be unlawful for any public officer, deputy, or
31 assistant to devote any time or labor during usual office hours toward the
32 campaign of any other candidate for office or for the nomination to any

               (B) It shall be unlawful for any public officer or public

- 6 (3) It shall be unlawful for any public officer, deputy, or assistant
- 7 who may be a candidate for the nomination to any office, or who may be a
- 8 candidate for any office to be voted for at any election, to use any office
- 9 or room furnished at public expense for his political headquarters or to send
- 10 out or distribute any letters, circulars, or other campaign literature from a
- 11 public office or room;
- 12 (4) It shall be unlawful for any person to assess any state employee
- 13 for any political purpose whatever or to coerce by threats or otherwise any
- 14 state employee into making subscription or contribution for any political
- 15 purpose;
- 16 (5) It shall be unlawful for any person employed in any capacity in
- 17 any department of the State of Arkansas to have membership in any political
- 18 party or organization which advocates the overthrow of our constitutional
- 19 form of government;
- 20 (6) It shall be unlawful for any campaign banners, cards, or campaign
- 21 literature to be placed on any cars, trucks, or tractors belonging to the
- 22 State of Arkansas or any municipality or county in the state;
- 23 (7) All articles, statements, or communications appearing in any
- 24 newspaper printed or circulated in this state, intended or calculated to
- 25 influence the vote of any elector in any election, and for the publication of
- 26 which a consideration is paid, or to be paid, to the proprietor or publisher
- 27 of the newspaper, shall be preceded or followed by the word Advertisement
- 28 in conspicuous letters;
- 29 (8) Unless the statement, communication, advertisement, circular,
- 30 pamphlet, form letter, mimeographed, printed, duplicated, or other similar
- 31 matter plainly bears the name or names and post office addresses of the
- 32 individuals, firms, committees, or other group or groups sponsoring and
- 33 bearing the cost, no statement, communication, or advertisement of a
- 34 political nature may be published in a newspaper or other periodical within
- 35 the State of Arkansas, and no circular, pamphlet, letter, form letter,

- 1 statement, advertisement, or other similar matter of a political nature, may
- 2 be printed or distributed in this state. If the sponsors thereof are not the
- 3 same persons, groups, committees, or organizations bearing the cost thereof,
- 4 then the names of both the sponsor and those bearing the cost shall plainly
- 5 appear upon the advertising matter. If the sponsor, or those bearing the
- 6 cost thereof, are a group, committee, association, council, or other body,
- 7 then the names of the three (3) principal officers of the sponsoring or
- 8 paying groups, committees, associations, councils, or other bodies, together
- 9 with the correct post office address of each, shall also be printed thereon;
- 10 (9) No officer of election shall do any electioneering on any election
- 11 day. No person shall hand out or distribute or offer to hand out or
- 12 distribute any campaign literature or any literature regarding any candidate
- 13 or issue on the ballot, solicit signatures on any petition, solicit
- 14 contributions for any charitable or other purpose, or do any electioneering
- 15 of any kind whatsoever within three hundred feet (300_) of any polling place
- 16 on election day;
- 17 (10) No person shall willfully disturb or engage in riotous conduct at
- 18 or near any polling place with the intent or effect of disturbing or
- 19 interfering with the access of the electors to the polling place;
- 20 (11) It shall be unlawful for any person or group of persons to
- 21 solicit or receive money or other valuable consideration from any political
- 22 candidate for office where the return consideration is a promise to place, or
- 23 placement of, the candidate's name or identity among a list or register of
- 24 recommended candidates for office;
- 25 (12) It shall be unlawful for any person or group of persons to
- 26 distribute or cause to be distributed, on election day, any list or register
- 27 as is contemplated in subdivision (11) of this section;
- 28 (13) It shall be unlawful for any person or group of persons to
- 29 knowingly carry, or cause to be carried or transmitted, into any polling
- 30 place on election day, any list or register as is contemplated in subdivision
- 31 (11) of this section or to refer to any list or register while marking his
- 32 ballot;
- 33 (14) No judge, clerk, or election sheriff shall perform any of the
- 34 duties of their respective positions before taking and subscribing to the
- 35 oath provided for in § 7-4-110;

- 1 (15) No person applying for a ballot shall swear falsely to any oath 2 administered by the election judges with reference to their qualifications to 3 vote;
- 4 (16) No person shall willfully cause or attempt to cause his own name 5 to be registered in any other election precinct than that in which he is or 6 will be before the next ensuing election qualified as an elector;
- 7 (17) During any election, no person shall remove, tear down, or 8 destroy any booths or supplies, or other conveniences placed in any booth or 9 polling place for the purpose of enabling the voter to prepare his ballot;
- 10 (18) No person shall take or carry any ballot obtained from any judge 11 outside of the polling room or have in his possession outside of the polling 12 room before the closing of the polls any ballot provided by any county 13 election commissioners;
- 14 (19) No person shall furnish a ballot to any elector who cannot read
 15 informing him that it contains a name or names different from those which are
 16 written or printed thereon or shall change or mark the ballot of any elector
 17 who cannot read so as to prevent the elector from voting for any candidate,
 18 act, section, or constitutional amendment as the elector intended;
- 19 (20) No election official or other person shall unfold a ballot or, 20 without the express consent of the voter, ascertain or attempt to ascertain 21 any vote on a ballot before it is placed in the ballot box, or make or place 22 any mark or device on any ballot for the purpose or with the effect of 23 identifying the ballot with the elector;
- (21) No person shall print or cause to be printed any ballot for any election held under this act with the names of the candidates appearing thereon in any other or different order or manner than provided by this act;
- (22) No election judge or clerk shall permit the vote of any person to be cast in any election precinct in this state in any election legally held in this state when the person does not appear in person at the election precinct and actually cast the vote. This subsection shall not apply to persons entitled to cast absentee ballots;

- 8 SECTION 2. Arkansas Code 7-1-104 is amended to read as follows:
- 9 "7-1-104. Miscellaneous felonies Penalties.
- The following offenses shall be deemed felonies punishable as provided in this section:
- 12 (1) No person shall falsely make or fraudulently destroy any
- 13 certificate of nominations, or any part thereof, file any certificate of
- 14 nominations, knowing the certificate, or any part thereof, to be false;
- 15 suppress any nomination which has been duly filed, or any part thereof; or
- 16 forge or falsely write the name or initials of any judge of election on any
- 17 ballot;
- 18 (2) No public official or deputy responsible for registration shall in
- 19 any manner willfully or corruptly permit any person not entitled to register
- $20\,$ for the purpose of voting to do so; or forge a registration or attempt to do
- 21 so;
- 22 (3) No person shall vote in any election in the state unless the
- 23 person is a qualified elector of this state and has registered to vote in the
- 24 manner provided by law;
- 25 (4) It shall be unlawful for any person to offer, accept, receive, or
- 26 pay any person any money, goods, wares, or merchandise or to solicit any
- 27 money, goods, wares, or merchandise for the purpose of influencing his or her
- 28 vote during the progress of any election in this state;
- 29 (5) It shall be unlawful for any person to make any threat or attempt
- 30 to intimidate any elector or the family, business, or profession of the
- 31 elector, and it shall be unlawful to attempt to prevent any qualified elector
- 32 from voting at any election;
- (6) It shall be unlawful to distribute any ballots outside of those
- 34 ballots ordered for use in the election for the purpose of instructing voters
- 35 how to vote. It shall be lawful for any newspaper to print or for any

- 1 television station to telecast a replica of the official ballot for the
- 2 purpose of familiarizing electors with the ballot prior to the day of
- 3 election;
- 4 (7) It shall be unlawful for any person to attend any voting place on
- 5 election day and hand out or give away any campaign cards, placards, or other
- 6 articles for the purpose of influencing the electors to vote for any
- 7 candidate within three hundred feet (300) of any polling place on election
- 8 day;
- 9 (8) No person shall tamper with a voting machine or fraudulently
- 10 affect or attempt to affect its results;
- 11 (9) No person may cast a ballot in more than one (1) party primary
- 12 election on the same day in this state or for candidates for more than one
- 13 (1) political party;
- 14 (10) No person shall vote in any election more than one (1) vote;
- 15 (11) No person shall vote or attempt to vote other than his or her
- 16 legal ballot;
- 17 (12) No judge of any election shall knowingly permit any person to

- 19 (13) No election official or other person shall fraudulently permit

- 32 (17) Any person who violates the provisions of § 7-5-702 or who shall
- 33 disclose how any voter may have voted, unless compelled to do so in a

(18) Any person convicted of a felony as defined in this section shall

19 other provisions or applications of the act which can be given effect without
20 the invalid provision or application, and to this end the provisions of this
21 act are declared to be severable.
