7 "AN ACT TO AMEND ARKANSAS CODE 19-5-501(b)(1)(B) RELATIVE
8 TO THE USE OF THE BUDGET STABILIZATION TRUST FUND TO MAKE
9 LOANS TO THE DEPARTMENT OF CORRECTION FARM FUND; AND FOR
10 OTHER PURPOSES."

Subtitle

12 "RELATING TO THE USE OF THE BUDGET
13 STABILIZATION TRUST FUND TO MAKE LOANS
14 TO THE DEPARTMENT OF CORRECTION FARM
15 FUND."

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

18

19 SECTION 1. Arkansas Code 19-5-501(b)(1)(B) is amended to read as
20 follows:

21 "(B) The loans made to the Department of Correction Farm Fund are to
22 be repaid on or before June 30 of the fiscal year following the fiscal year
23 in which the loan was made after the amount of the outstanding loan made the
24 previous fiscal year has been reduced by the value of products produced or
25 processed on the farm that were consumed by inmates and other authorized
26 personnel, in amounts as determined and certified by the Legislative Auditor
27 to the Chief Fiscal Officer of the State. *Processed beef purchased by the*
28 *Department of Correction must be U.S. labeled.* The value of products
29 produced or processed on the farm that were consumed by inmates and other
30 authorized personnel shall be based upon prices obtained by the Department of
31 Correction and the State Purchasing Director for purchasing similar products
32 and quantities on the open market for other state agencies, institutions, and
33 universities. However, the Chief Fiscal Officer of the State may grant an

1 extension of not to exceed sixty (60) days for repayment of loans made to the
2 Department of Correction Farm Fund upon receipt by him of a certification by
3 the Director of the Department of Correction that farm products are held in
4 storage or are on hand that exceed in market value the amount of loans that
5 are due, and the Chief Fiscal Officer of the State may grant an additional
6 extension of not to exceed sixty (60) days for repayment of the loan made to
7 the Department of Correction Farm Fund, after obtaining the advice of the
8 Arkansas Legislative Council in regard to a request from the Department of
9 Correction for the additional sixty-day extension for repayment of the loan.
10 Loans made to the Department of Correction Prison Industry Fund for operation
11 expenses shall be repaid on or before June 30 of the fiscal year in which the
12 loan was made, but loans made for the purchase of equipment necessary for
13 implementing the various industries shall be repaid from time to time."

14

15 SECTION 2. All provisions of this act of a general and permanent
16 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
17 Code Revision Commission shall incorporate the same in the Code.

19 SECTION 3. If any provision of this act or the application thereof to
20 any person or circumstance is held invalid, such invalidity shall not affect
21 other provisions or applications of the act which can be given effect without
22 the invalid provision or application, and to this end the provisions of this
23 act are declared to be severable.

25 SECTION 4. All laws and parts of laws in conflict with this act are
26 hereby repealed.
