21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

         SECTION 1. Arkansas Code § 24-7-807 is amended to read as follows:

         "24-7-807. Participation in plan.
         Participation in an alternate retirement plan established pursuant to

26 this subchapter shall be as follows:
         (1) Any staff member employed or appointed by a college or university

   on or after the establishment of its alternate retirement plan shall
  participate in the plan or in the teacher retirement system;
         (2) Any staff member employed or appointed by a college or university
31 prior to July 1, 1969, who is a member of the retirement system shall
32 continue in such membership or shall participate in the alternate retirement
33 plan, as provided in this subchapter;
         (3)(A) Any staff member employed or appointed by a college or

35 university with fewer than ten (10) years of member service in the retirement

1 system may elect to terminate his membership in the retirement system and 2 participate in the alternate retirement plan established by the employing 3 college or university. (B) The election shall be in writing and filed with the 5 retirement system and the disbursing officer of the employing college or 6 university within one (1) year after he becomes eligible to participate in 7 the alternate retirement plan, except that, on or after July 1, 1993, until 8 December 31, 1993, any staff member employed or appointed by a college or 9 university who has fewer than ten (10) years of member service in the 10 retirement system and who has not already so elected, may elect to terminate 11 his membership in the retirement system and participate in the alternate 12 retirement plan established by the employing college or university. Such election shall be in writing and filed with the retirement system and the 14 disbursing officer of the employing college or university. 15 (C) All accumulated contributions to the credit of the staff 16 member in the members' deposit account which is maintained pursuant to the 17 provisions of § 24-7-406 shall be returned to the staff member, and all of 18 his credited service under the retirement system shall be cancelled; (4)(A) Any staff member employed or appointed by a college or 19 20 university with ten (10) or more years of credited service who elects to 21 participate only in the alternate retirement plan and who has left his 22 contributions in the retirement system shall be eligible to receive an 23 annuity on or after attaining sixty (60) years of age and on his retirement 24 from covered employment. The amount of the annuity shall be determined by 25 the benefit formula of the retirement system at the time of his retirement. The election authorized under subdivision (4)(A) of this 26 27 section shall be made in writing and filed with the retirement system and 28 with the disbursing officer of the employing college or university on or 29 before July 1 of the year in which the person makes the election to 30 participate in the alternate retirement plan. The person's annuity shall 31 begin on the first day of the month following the date his application for 32 retirement is filed with the board of trustees on or after his attainment of 33 age sixty (60) years; (5)(A) Any department employee who transferred from another state 34

35 department covered by a state-supported retirement system may elect to

- 1 participate in an alternate retirement plan. Such employee shall file 2 written notice of his election with the executive director of the department.
- 3 (B) Any department employee with ten (10) or more years of
- 4 credited service who elects to participate only in the alternate retirement
- 5 plan and who has left his contributions in the retirement system shall be
- 6 eligible to receive an annuity on or after attaining the normal retirement
- 7 age and on his retirement from covered employment. The amount of the annuity
- 8 shall be determined by the benefit formula of the retirement system at the
- 9 time of his retirement.
- 10 (C) The election authorized under this subsection shall be made
- 11 in writing and filed with the retirement system and with the Director of the
- 12 State Department of Higher Education on or before July 1 of the year in which
- 13 the person makes the election to participate in the alternate retirement
- 14 plan. The person's annuity shall begin on the first day of the month
- 15 following the date his application for retirement is filed with the board of
- 16 trustees on or after his attainment of normal retirement age and on his
- 17 retirement from covered employment.
- 18 (D) Effective July 1, 1995, staff members who elect to
- 19 participate in an alternate retirement plan may elect to become members of
- 20 the retirement system. Service credit forfeited while a member of an
- 21 alternate retirement plan cannot be established in the retirement system.
- 22 The election to withdraw from the alternate retirement plan and become a
- 23 member of the retirement system shall be made by December 31, 1995, and
- 24 notice of the election shall be made in writing and filed with the retirement
- 25 system and the disbursing officer of the employing college or university by
- 26 December 31, 1995."
- 27 SECTION 2. Arkansas Code § 24-7-907 is amended to read as follows:
- 28 "24-7-907. Participation in plan.
- 29 Participation in an alternate retirement plan established pursuant to
- 30 this subchapter shall be as follows:
- 31 (1) All staff members shall participate in either the retirement
- 32 system or an alternate retirement plan, or may participate in both, but
- 33 participation in both shall be limited to the circumstances described in
- 34 subdivision (2) of this section;
- 35 (2) Any staff member who has become fully vested in the retirement

- 1 system may:
- 2 (A) Continue as an active member of the retirement system;
- 3 (B) Discontinue contributing to the retirement system, thus
- 4 becoming an inactive member of the retirement system, and participate instead
- 5 in an alternate retirement plan. Under those circumstances, the staff member
- 6 would be both an inactive member of the retirement system and an active
- 7 member of the alternate retirement plan; or
- 8 (C) Participate in an alternate retirement plan and receive all
- 9 accumulated contributions to the credit of the staff member in the members'
- 10 deposit account which is maintained pursuant to the provisions of § 24-7-406
- 11 and have the member's credited service under the retirement system cancelled.
- 12 (3) Any staff member who has participated in the retirement system for
- 13 a period which is insufficient to allow for full vesting of that staff
- 14 member's retirement system benefits may:
- 15 (A) Continue as an active member of the retirement system;
- 16 (B) Discontinue membership in the retirement system and transfer
- 17 from the retirement system into his account with the alternate retirement
- 18 plan, i.e., roll over all contributions which the staff member has previously
- 19 made to the retirement system; or
- 20 (C) Participate in the alternate retirement plan and receive all
- 21 accumulated contributions to the credit of the staff member in the members'
- 22 deposit account which is maintained pursuant to the provisions of § 24-7-406
- 23 and have the member's credited service under the retirement system cancelled.
- 24 (4) No staff member may participate in an alternate retirement plan
- 25 without giving prior written notice of his election to participate in the
- 26 alternate retirement plan. The notice of election shall be in writing on a
- 27 form established by the division and filed with both the director and the
- 28 retirement system. New staff members shall make the election within ninety
- 29 (90) days after the date of their employment.
- 30 (5)(A) Effective July 1, 1995, staff members who elect to participate
- 31 in an alternate retirement plan may elect to become members of the retirement
- 32 system.
- 33 (B) Service credit forfeited while a member of an alternate
- 34 retirement plan cannot be established in the retirement system.
- 35 (C) The election to withdraw from the alternate retirement plan

1 and become a member of the retirement system shall be made by December 31,
2 1995, and notice of the election shall be made in writing to the director and
3 the retirement system by December 31, 1995."
         SECTION 3. All provisions of this act of general and permanent nature
5 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
6 Revision Commission shall incorporate the same in the Code.

         SECTION 4. If any provisions of this act or the application thereof to
9 any person or circumstance is held invalid, the invalidity shall not affect
10 other provisions or applications of the act which can be given effect without
11 the invalid provisions or application, and to this end the provisions of this
12 act are declared to be severable.

         SECTION 5. (a) Arkansas Code § 24-7-802 is hereby repealed.

         (b) All laws and parts of laws in conflict with this act are hereby
16 repealed.

         SECTION 6. Emergency. It is hereby found and determined by the
18
19 Eightieth General Assembly of the State of Arkansas that certain staff
20 members of the Arkansas Technical and Community College system are unable to
21 achieve an equitable retirement under the current provisions of Arkansas law;
22 that the retirement laws regarding alternate retirement plans in Arkansas
23 need to be changed to solve this inequitable situation; and that those laws
24 need to be amended and this act needs to be effective at the beginning of the
25 state fiscal biennium to continue the effective and efficient operation of
26 the Arkansas Technical and Community College system in Arkansas.
27 in order to promote effectiveness in state government, an emergency is hereby
28 declared to exist, and this act being necessary for the immediate
29 preservation of the public peace, health, and safety, shall be in full force
30 and effect from and after July 1, 1995.
