14 "TO FURTHER DEFINE THE INCIDENTAL USE OF
15 AN IMPLEMENT OF HUSBANDRY AS AN
16 EXCEPTION TO ARKANSAS_ LAWS ON MOTOR
17 VEHICLE REGISTRATION"

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. Arkansas Code § 27-14-703 is amended to read as follows:

22 "27-14-703. Vehicles subject to registration - Exceptions.

23 (a) Every motor vehicle, trailer, semitrailer, and pole trailer when
24 driven or moved upon a highway and every mobile home shall be subject to the
25 provisions of this chapter except:

26 (1) Any vehicle driven or moved upon a highway in conformance
27 with the provisions of this chapter relating to manufacturers, transporters,
28 dealers, lienholders, or nonresidents or under a temporary registration
29 permit issued by the office as authorized in § 27-14-708;

30 (2) Any vehicle which is driven or moved upon a highway only for
31 the purpose of crossing such highway from one (1) property to another;

32 (3) Any implement of husbandry whether of a type otherwise
33 subject to registration under this chapter or not which is only incidentally
34 operated or moved upon a highway;

35 (4) Any special mobile equipment as defined in § 27-14-211;

1 (5) Any vehicle which is propelled exclusively by electric power
2 obtained from overhead trolley wires, though not operated upon rails;

3 (6) No certificates of title need be obtained for any vehicle of
4 a type subject to registration owned by the federal government.

5 (b) For the purposes of this section, the operation or movement upon a
6 highway of an implement of husbandry owned, hired, rented, or leased by a
7 farmer shall be deemed to be incidental for purposes of this section if the
8 movement or operation is undertaken for purposes related to raising
9 agricultural, horticultural, or livestock products on property owned or
10 leased by a farmer. Incidental operation or movement includes transporting
11 seeds, agricultural chemicals, or fertilizers from one work area or a storage
12 area to another place for application to or use on the farmer_s own land
13 whether owned or leased."

15 SECTION 2. All provisions of this act of general and permanent nature
16 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
17 Revision Commission shall incorporate the same in the Code.

18

19 SECTION 3. If any provisions of this act or the application thereof to
20 any person or circumstance is held invalid, the invalidity shall not affect
21 other provisions or applications of the act which can be given effect without
22 the invalid provisions or application, and to this end the provisions of this
23 act are declared to be severable.

25 SECTION 4. All laws and parts of laws in conflict with this act are
26 hereby repealed.
